### Community Updates

The City of Rosemount will update the public on work toward an indoor recreation center during an open house on **December 9**. The City Council authorized planning to decide if a center would be feasible and what features it should contain. Project planners considered feedback the public provided earlier this year. During the December open house, the team will discuss what amenities the center would contain, how it would be operated, where it might be placed, and what its updated cost could be. Attendees will have the opportunity to ask questions of the project team and Council members. There will also be an estimated timeline for the work. The open house will take place Monday, December 9, from 6:30 to 8 p.m. in the Banquet Hall of the Rosemount Community Center, 13885 South Robert Trail.

**Fusion Asian Food** will be opening at 14897 S Robert Trail in the former Eddie Cheng location. The Chinese fusion inspired restaurant is open to the public in early December.

## Building Activity

October was a record building month for the Twin Cities and Rosemount claimed a top spot in permit activity. Capping off the biggest October number since 2003, Metro area home building continued at a robust pace. Rosemount was a hot spot in the Twin Cities and issued 23 building permits totaling 77 housing units – placing us 4<sup>th</sup> in total building activity for the month!
