

[Georgia Property Tax Exemptions](#)

The State of Georgia's Department of Revenue states that a homeowner is entitled to a homestead exemption on their home and land underneath provided the home was owned by the homeowner and was their legal residence as of January 1st of the taxable year. If your home is located within city limits, you may need to file for exemption with the city as well. Seniors, Veterans & Disabled citizens may qualify for additional tax exemptions. You will find that information on these links also. For most counties if there is a deadline, it is April 1st—check your county link for more details:
