ORGANISATION IMPROVEMENT THROUGH BETTER AND GREATER USE OF DATA



Norfolk's Adult Social Care continues to face challenges and needed higher quality reporting to inform daily operations and greater insight into operational and strategic planning. To meet the ever-increasing demand, Norfolk's Insight & Analytics team developed a novel highly effective approach.

We have moved to a data model that allows all reporting to come from a single dataset that ensures data accuracy, speed of production and access, more usable products and (later) the ability to connect different data department models to provide greater understanding across the Council's business. In parallel we are heavily involved in the creation of a Shared Care Record (Health and Social Care) and working with our ICB to create an Azure-based dataset for further sharing.

The benefits are considerable and it is an exciting team to be working in.
