We hope to encourage organizations and civic groups to beautify their communities and enhance their quality of life through horticulture. Since 2006 the Greening of Arkansas Grant Program has been funded from proceeds from the Arkansas Flower and Garden Show, Inc. along with support from other entities.

Grants may be used to construct plantings to beautify neighborhood parks and public spaces. Grant awards are available up to \$2,500 at the discretion of the Greening of Arkansas Grant Committee. A lesser grant amount may be awarded based on the project's merits and benefits to the community.

GREENING OF ARKANSAS GRANT PROGRAM

A PROGRAM DEVELOPED AND MANAGED BY THE ARKANSAS FLOWER & GARDEN SHOW BOARD OF DIRECTORS

The Greening of Arkansas program supports the development and ongoing care of green spaces in towns across Arkansas. Working in partnership with neighborhood residents, community organizations and local governments, the Greening of Arkansas Grant program was developed to promote the idea of a greener and cleaner environment by encouraging civic plantings in the community. This program can promote community pride, rejuvenate streets, re-energize neighbors, and improve Arkansas' image.

General Requirements:

1. Applicants must be a non-profit community-based or civic organization located in the State of Arkansas.
2. Grant award funds may only be used for the project in the area defined in the plan and project description.
3. At least **60%** of grant award funds must be used for plant material (trees, shrubs, flowers, etc.)
4. Applications for beautification projects with long-term and broad impact in a community will be scored higher and are more likely to be funded. Sustainable projects that will continue to benefit a community for years to come are more likely to be funded.
5. Grant funds will NOT provide awards for projects on private property.
6. Organizations who receive a Greening Grant must wait two years before they can apply for another.
7. Award application must include **four copies** of the following: 1) application form; 2) project summary form with attached diagrams and documents; and 3) photograph of intended site. **Incomplete applications will be eliminated in an initial screening of applications.**
8. A Final Report & Record of Expenses must be sent to the Arkansas Flower & Garden Show (AF&GS) one year after the grant is received. The Final Report may be in the form of a PowerPoint presentation or other digital format.
9. If all of the grant award funds are NOT used by March 1, 2020, the remaining funds will be returned to the AF&GS by April 15, 2020.

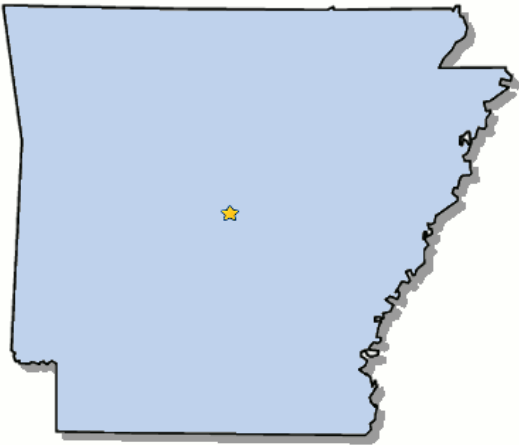

The AF&GS can provide a photo release form if needed.
