#### The Club

The LEBC is a registered Club Level III (non-profit) Amateur Athletic Union (AAU) affiliated organization.

#### Our Purpose

The purpose of this organization is to educate, promote, and provide competitive basketball for children who live within the Placer Union High School District and will attend Del Oro High School.

#### Our Mission

The LEBC mission is to provide players the opportunity to develop their overall game and increase their self-confidence. We will achieve this by creating an environment for athletes to learn, improve skills, build character and compete against the best teams and athletes in the region.

We understand there are other sports and activities players want to participate in. The club wants to reinforce the athlete's opportunity to play multiple sports. Teams will be formed and players evaluated based on the assumption that players will be allowed to miss some practices and even tournaments to honor their current commitments.

All tryouts are in the Bonner Gym, Del Oro High School. Please come prepared to play. If you have a reversible jersey please bring it. Otherwise please wear a white t-shirt (printing OK) so we can form teams for scrimmages. You need only to make one tryout time to be eligible for the team. We know you have other sports. ### **Ages**

3rd-4<sup>th</sup> grades will have a special 3 on 3 with 8 foot basket training program to be run by Steve Evans, former Basketball Coach at Del Oro. Current Del Oro players will be coaches also. We will send out more information in early October.

Teams will be formed for 5<sup>th</sup>-8<sup>th</sup> grade players. If you are an experienced coach and have an interest in coaching please contact us at the email address below.

### **Time Commitment**

Practices will be at least twice a week and start in December. There will be 4 tournaments starting in mid-January through the middle of March. Our Spring season will start shortly thereafter. More information on the Spring season will be available at a later date. Separate seasons will be determined by team. Some may have only one season.

### **Are There Cuts?**

These teams would be broken down into the Black/Gold/White teams as needed and will be split up by ability and experience. Del Oro coaches and the Board will help determine the team rosters. We may make cuts in order to give a fair amount of playing time to all who make the team. We will cap teams at 10 players. If we do not have enough players to form full teams or do not have an approved coach cuts may be made. It is our intent not to have players “ply up” or have mixed grade teams.

### **Cost**

The cost of playing will be approximately \$250-275 per player per season. The goal is 10 players per team. The fee pays for the practice courts and tournament fees. In addition to this fee, there is a uniform cost of approximately \$60. All fees must be paid prior to your child receiving a uniform and participating in practice. There will be no exceptions.

Partial scholarships approved by the Board may be available. Scholarship applications will be available at tryouts.

### **Fundraising**

In order to keep costs to a minimum, we have a fundraiser. Each player will be responsible for selling \$50 worth of merchandise. An opt-out clause for \$50 is also available. More information will be available when teams are formed.

## **Will AAU conflict with ARD?**

The simple answer is yes for the 5<sup>th</sup> to 8<sup>th</sup> grade teams. Both squads will have two practices a week and we will both have games Saturdays. For the 3<sup>rd</sup>-4<sup>th</sup> grade training program the kids could do both ARD and AAU with minimal conflict. The Lady Eagles 3<sup>rd</sup>-4<sup>th</sup> program will not have weekly practices. The cost will be minimal.
