**SUBJECT:** Final Selection and Commencement of Centralized Examination Station Operations in the Port of New York/Newark

**DATE:** **25 MARCH 2024**

**REFERENCES:** *19 C.F.R. 118; 19 C.F.R. 151.1-7, 15; Port of New York/Newark Informational Pipeline No. 24-014-NWK (Tentative Selection of Applicants Seeking to Operate a Centralized Examination Station in the Port of New York/Newark – dated February 9, 2024)*

**PURPOSE:**

The purpose of this pipeline is to notify the trade community of the final selection of Centralized Examination Station (CES) operators in the Port of New York/Newark. Additionally, it identifies hours of operation, important points of contact and fees for each CES. These selections are effective as of March 25, 2024 and will remain in effect until January 8, 2027. The number of operators has increased in concert with the current workload and U.S. Customs and Border Protection (CBP) resources.

**BACKGROUND:**

In Informational Pipeline No. 24-014-NWK, titled “Tentative Selection of Applicants Seeking to Operate a Centralized Examination Station in the Port of New York/Newark,” CBP announced the tentatively selected CES bidders as follows:

**ACTION:**

Effective March 25, 2024, both Port Liberty CES LLC and SalSon have been selected during the interim CES Solicitation and may operate as a CES through January 8, 2027.

The following four (4) CES facilities will be used to perform examinations of seaport cargo in the Port of New York/Newark to include: non-intrusive inspections (NII), agriculture, commercial and enforcement examinations.

The Comprehensive CES will be responsible for presenting cargo to CBP for both Enforcement/Trade Compliance (including NII) and Agriculture examinations. All outbound examinations will be directed to the carrier designated CES.

In the event of emergency or an overflow situation at a designated CES, CBP will redirect cargo to another CES to facilitate the examination process (19 C.F.R. § 151.6).

Attached to this pipeline are the fee schedules for each CES.

During the next thirty (30) calendar days, the public has the opportunity to submit written comments to the Port Director, New York/Newark regarding the selected CESs. After the conclusion of that period, all comments will be reviewed and evaluated. Comments should be submitted in writing to:
