Haven House Information

Haven House, located in Sandoval County New Mexico, is the only domestic violence shelter serving the rural areas of that county as well as Rio Rancho. Domestic violence is a major issue affecting Rio Rancho and Sandoval County in particular. In the most recent published statewide statistics of domestic violence, Sandoval was identified three out of the last four years as the #1 county in the state regarding the number of incidents reported by law enforcement. Over 80% of the reported incidents of domestic violence occurred in the City of Rio Rancho (Source: Incidence and Nature of Domestic Violence in New Mexico XIV: An Analysis of 2014 Data). Most often, however, domestic violence is not reported to the police.

The mission statement of Haven House, Inc. is to "Help domestic violence victims gain immediate safety plus the knowledge, skills and resources to succeed in lives free of violence." We incorporated in 1994 as a non-profit 501(c)3, under the name Project Sandoval County. In 2002 the name was changed to Haven House Inc. with the opening of the physical shelter facility with 20 beds. In 2011 we increased the capacity of the shelter by 60% to 32 beds. Haven House services focus on the health and wellbeing of the clients and their children, as well as on learning skills that will help them to lead a violence-free life after they leave the shelter.

For 25 years Haven House has provided services that meet the physical and emotional needs of victims. The shelter has a calm, safe environment so that victims can learn to heal. The case management, Therapeutic Counseling, Group Counseling, Crisis Counseling, Follow-up Contacts, Crisis Hotline, Information/Referrals, and phone contacts are all designed to be culturally and linguistically appropriate for our clients and to address any barriers to victim safety so they may lead a life free of violence.

The domestic violence epidemic affects women and children of all backgrounds regardless of race, age socioeconomic status, or sexual orientation. Haven House serves the most vulnerable domestic violence victims, and our clients are those with fewer resources than the general public. Of the approximately 1000 clients we serve annually out of shelter, 85% are low to moderately low income based on federal standards. The clients that we serve specifically in shelter are at an even lower rate: approximately 95% of them fall into the very low to no income categories.

Although Haven House is a shelter, the mainstay of our program is the services our staff provides to the clients. Our staff provide the case management and supportive services needed to transform the women fleeing abusive relationships from victims to survivors.
