CHINATOWN COMMUNITY FOUNDATION 17TH ANNUAL INVITATIONAL GOLF TOURNAMENT RELEASE AND WAIVER OF LIABILITY

By choosing to participate in the Chinatown Community Foundation (CCF) 17th Annual Invitational Golf Tournament and its related events and activities ("Tournament"), currently scheduled for October 16th, 2025, I acknowledge that I am doing so voluntarily as a participant or volunteer ("Participant"). I accept full responsibility for myself and for the actions and well-being of the players on my team. I understand and accept the inherent risks involved in the Tournament and, by participating, I release the Chinatown Community Foundation (CCF) and its officers, directors, employees, and agents (collectively "CCF") from any and all claims, liabilities, damages, or causes of action related to any injury, loss, or incident that may occur as a result of my participation or attendance, or that of my team members.

Acknowledgement of Risks

I acknowledge that my participation in the Tournament entails known and unanticipated risks that could result in physical, psychological, or emotional injury, paralysis, death, or damage to myself, to property, or to third parties. I understand that such risks cannot be eliminated without jeopardizing the essential qualities of the Tournament.

Inherent and Potential Risks

I understand and acknowledge that the Tournament involves strenuous physical activity related to the game of golf. I understand and agree that such physical activity and the game of golf, by its very nature, carries with it certain inherent risks and I assume all such risks. **Such risks include, but are not limited to:** being struck by golf balls and/or golf equipment; collision with other Tournament Participants, golf carts, trees, or other persons or property; forces of nature including heavy rain, strong winds, other adverse weather conditions, and potentially rapidly changing weather conditions; damage to or loss of property or valuables; exposure to sun, sunburn, hyperthermia (heat related illness), heat exhaustion, and/or dehydration; personal injuries due to physical exertion associated with the Tournament; and loss or damage to any of my personal items or property before, during, or after the Tournament. I understand and acknowledge that such inherent and potential risks may result in physical, psychological, or emotional injury; paralysis; death; permanent disfigurement; or damage to myself, to property, or to third parties. In addition, social gatherings such as this Tournament may involve potential risk of illness, medical complications, injury, or death associated with diseases such as COVID-19.

Food and Beverage / Alcohol Consumption

I attest that I am 21 years of age or older and assume all risks associated with consuming any food or drink, including any alcoholic beverages, available during the Tournament. I agree to take full responsibility for my actions, safety, and welfare. I acknowledge and agree that consumption of alcohol at the Tournament is optional and a personal decision. I agree that any alcoholic beverages I consume are at my own choice and responsibility. I agree to drink responsibly and to not drink any alcoholic beverage to the extent that my judgment is impaired. I acknowledge and agree that CCF shall not be responsible or liable for any accident, injury, theft, loss, or damage caused by my impaired judgment related to my alcohol consumption.

I agree to dress appropriately to mitigate risk of physical injury to myself including, but not limited to: wearing attire and shoes appropriate for the game of golf and dressing in conjunction with the weather.

Consistent with applicable law, firearms are strictly prohibited during the Tournament. I agree not to bring any firearm or any other device or item that could inflict serious or fatal bodily harm or injury.

Medical Evaluation

I attest that I am medically and physically able to participate in the Tournament. If I have any concerns regarding my participation in the Tournament, I take full responsibility for consulting a medical professional. I attest that, if I am pregnant, have any physical or mental impairment, recently suffered an illness, injury, or impairment, I should have or did consult a medical professional prior to participating in the Tournament.

In the event of an accident, illness, or medical emergency during the Tournament, I authorize CCF to seek emergency medical treatment and/or transportation on my behalf. I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating in the Tournament, or I agree to bear the cost(s) of such injury or damage myself. I further certify that I am willing to assume the risk of any pre-existing medical or physical conditions I may have.

I voluntarily release, waive, hold harmless, and covenant not to sue CCF from any and all claims, demands, or causes of action, which are in any way connected with my participation in the Tournament, **including any such claims which allege negligent acts or omissions of CCF**. Should CCF incur attorneys' fees and costs to enforce this agreement, I agree to indemnify and hold CCF harmless for all such fees and costs.

Voluntary Participation

I am fully aware of and understand the risks connected with participation in the Tournament, whether specifically listed in this Waiver or not, and I voluntarily elect to participate in the Tournament knowing that my participation involves or may involve such risks.

Media Release Agreement

I authorize and give full consent to CCF to copyright, disclose, maintain, and/or publish for public view in any hardcopy or electronic format or platform any and all photographs, digital recordings, videotapes, film, or other recorded images ("Images") in which I may appear. I understand and agree that CCF may transfer, use, or cause to be used, these Images for any exhibits, public displays, publications, commercials, art and advertising purposes, television programs, internet, and/or other platforms without limitation or reservation.

Governing Law and Severability

I acknowledge and agree that Hawai'i law shall apply in the interpretation of this agreement and in any action without regard to the conflict of law rules. If any portion of this agreement is found to be void or unenforceable, I agree that the remaining document shall remain in full force and effect.

By participating in the CCF Tournament—whether as a player, volunteer, vendor, or other participant—I acknowledge that if I or anyone else is injured or if property is damaged during my involvement in the Tournament, I may be found by a court of law to have waived my right to maintain a lawsuit against CCF based on any claim I have released herein. I have had sufficient opportunity to read this entire document. I have read and understood this agreement, and I agree to be bound by its terms. I accept responsibility for myself and, if applicable, any team members, staff, or representatives associated with my participation.
