Day 1: Overnight Flight from Denver to Nairobi

Day 2: Arrive Nairobi, Kenya (D)

Welcome to Kenya. Arrive Jomo Kenyatta International Airport. After customs and immigration formalities, you will be welcomed and transferred to your hotel. Dinner at hotel. Overnight: Fourpoints by Sheraton JKIA (4*)

Day 3: Nairobi – Arusha – Tarangire National Park (Tarangire Tree Tops) (B,L,D)

After early breakfast, return to Jomo Kenyatta International Airport and Check in for your flight to Kilimanjaro International Airport, Tanzania.

On arrival, you are met by your safari team, they will drive you to **Tarangire Treetops Lodge** for a two night stay. After lunch, we will experience our first **Game Drive** to search for the “Big Five”. Lion, Elephant, Cape Buffalo, Rhino and Leopard. Dinner and overnight stay at the lodge.

Living A Dream High in The Trees describes the Lodge. Each Treetops room boasts one of the largest bedrooms to be found in any camp in East Africa. The rooms have private balconies that offer views across the Tarangire Plains. Overnight: **Tarangire Treetops Lodge**

Day 4: Tarangire National Park (B,L,D)

After breakfast, depart with picnic lunch boxes to **Tarangire National Park** for a full day **Game Drive**.

Tarangire National Park is Tanzania's best-kept secret on the northern safari circuit. It is named after a nearby river called Tarangire. This is a year-round park with distinct seasons offering different experiences, from dusty, dry and baking with animals clustered around the rapidly reducing river, to the fecund green season full of new-born animals and chattering birds. A lot of migratory animals aim to reside here during the dry season. You can see groups and herds of animals like 600 elephants followed by zebras, buffalos and oryxes who ventured from the Maasai to the Tarangire in search for water. There are also a few lions prowling around and looking for unsuspecting preys around the jungle. Some of the other animals that you may see here are antelopes, warthogs, hippos, cheetahs, leopards, foxes, jackals and waterbucks. Return to the lodge for dinner and overnight.

DAY 5: Tarangire National Park – Ngorongoro Conservation Park (B,L,D)

Enjoy breakfast at the Lodge and later depart with picnic lunch boxes and drive to **Lake Manyara National Park** for a mid-morning **Game Drive**. Keep your eyes open. Later drive to Karatu for check in at The Manor at Ngorongoro. Dinner at hotel.

The Manor at Ngorongoro is one of the first safari lodges of its kind to blend East African hospitality with old world Afro-European architecture. Each of the 18 Manor Cottage Suites has its own private entrance and adjoining private sun terrace. A double open-fronted log burning fireplace divides a room interior that mirrors the traditional Cape Dutch architecture.

DAY 6: Ngorongoro (B,L,D)

After breakfast, board your land cruiser for an amazing journey as you descend onto the floor of the **Ngorongoro crater**. The crater is a World Heritage site; an extinct volcano and the largest unbroken caldera in the world. The cone is believed to have collapsed nearly two million years ago, and while the cone was standing, it could have been as tall, if not taller, than Mount Kilimanjaro. The crater (1,800 feet deep and 102 square miles) is a microcosm of East African scenery with abundant wildlife including more than 25,000 larger animals, mostly **Zebra and Wildebeest**. As you descend, you might be able to see the local Maasai as they take their cattle down the steep walls of the crater. It is their right, negotiated with the government and parks authority, to graze their cattle in about 75% of the crater floor. The mix of cattle with the wild animals makes for some terrific photographs, and the interaction between domestic and wild animals is almost unbelievable. Your wildlife-viewing will be dramatic, and the experience memorable. Enjoy a hot barbeque lunch at the floor of the crater and continue viewing game before returning to the lodge for freshening up, dinner and overnight stay.

DAY 7: Ngorongoro – Serengeti National Park (B,L,D)

After breakfast, depart to the famous **Serengeti National Park**. Arrive at Serengeti Sopa in time for lunch. After lunch, embark on an afternoon **Game Drive** in the park.



The spectacle of predator versus prey will dominate the day during our Serengeti safari. Golden-maned lion prides feast on the abundance of plain grazers. Solitary leopards haunt the acacia trees lining the Seronera River, while a high density of cheetahs prowl the southeastern plains. Almost uniquely, all three African jackal species occur here, alongside the spotted hyena and a host of more elusive small predators, ranging from the insectivorous aardwolf to the beautiful serval cat. But there is more to a safari in the Serengeti Plain than large mammals. Gaudy agama lizards and rock hyraxes scuffle around the surfaces of the park's isolated granite kopjes. A full 100 varieties of dung beetle have been recorded, as have 500-plus

bird species, ranging from the outsized ostrich and bizarre secretary bird of the open grassland, to the black eagles that soar effortlessly above the Lobo Hills.

Return later as the sun sets for dinner and overnight.

Breakfast at the Lodge and later drive to Western Serengeti with **Game Drive** enroute. Arrive at Kirawira Luxury Camp in time for lunch. Afternoon **Game Drive** in the park. Dinner and overnight at the camp.
