Dr. Robert A. Barish, a distinguished physician and academic leader, is vice chancellor for health affairs of the University of Illinois at Chicago.

Dr. Barish oversees the University of Illinois Hospital & Health Sciences System (UI Health), which provides comprehensive care, education, and research to train healthcare leaders and foster healthy communities in Illinois and beyond. A part of the University of Illinois at Chicago (UIC), UI Health is a clinical enterprise that includes a 465-bed tertiary care hospital, 21 outpatient clinics, and 11 federally qualified Mile Square Health Center locations. With campuses in Chicago, Peoria, Quad Cities, Rockford, Springfield, and Urbana, the health system includes the academic and research activities of the seven UIC health science colleges: Applied Health Sciences, Dentistry, Medicine, Nursing, Pharmacy; the School of Public Health; and the Jane Addams College of Social Work. UI Health is dedicated to the pursuit of health equity.

He served as chancellor of the LSU Health Sciences Center at Shreveport from 2009 to 2015, where he provided leadership for the schools of medicine, allied health, and graduate programs; a major academic medical center; and two affiliated hospitals.

Dr. Barish spent 24 years at the University of Maryland School of Medicine. He served as chief of emergency medicine from 1985 to 1996 and built a nationally recognized program. He was named associate dean for clinical affairs in 1998 and vice dean for clinical affairs in 2005. That same year, following the devastation of Hurricane Katrina on the Gulf Coast, Barish helped lead a medical regiment dispatched by the state of Maryland to deliver emergency care to more than 6,000 hurricane victims in Jefferson Parish.

In addition to his medical duties at Maryland, Barish earned an M.B.A. from Loyola College in 1995. From 1996 to 1998, he served as the chief executive officer of UniversityCARE, a University of Maryland physician-hospital network of family-oriented health centers located in neighborhoods throughout the Baltimore metropolitan area.



A former lieutenant colonel and flight surgeon in the Maryland Air National Guard, Barish was among a select group invited to become a NASA astronaut candidate in the early 1990s.



**Toni Preckwinkle**

Cook County Board President Toni Preckwinkle has been a dedicated community leader for over two decades. She has worked with the Cook County Board of Commissioners, elected officials and County employees to implement major reform and reshape County government through fiscal responsibility, innovative leadership, transparency and accountability, and improved services.

Since taking office in December 2010, President Preckwinkle has rebuilt the credibility of County government, solving for more than \$1.6 billion in budget deficits and cutting \$577 million in expenditures. She established the County's first performance management initiative to demand more accountability from County operations and employees.

President Preckwinkle has developed a broad policy agenda – focusing on critical public safety reform, working to strengthen the County's health care system, and increasing the capacity and capability of our economic development efforts.

President Preckwinkle is also president of the Forest Preserves of Cook County, a separate governmental body. The FPCC is one of the oldest and largest forest preserve districts in the country spanning 69,000 acres, which makes up 11% of the County footprint.

Before being elected Cook County Board President, Preckwinkle served 19 years as Alderman of the 4th Ward. During her tenure she worked to improve our local public schools and increase the amount of affordable housing sponsoring two Living Wage and Affordable Housing ordinances. Her independent and progressive leadership earned her the IVI-IPO Best Alderman Award six times as well as two Leon Despres Awards.

Prior to holding elected office, President Preckwinkle taught high school history for 10 years. She holds a Bachelor's degree and Master's degree from the University of Chicago. She is the mother of two and the grandmother of three.

**Larry Huggins**

Larry Huggins is an industrious businessman and president and CEO of Riteway-Huggins Construction Services. Huggins has served in various capacities, most prominently as an executive in general contracting and construction management for commercial, municipal, and residential properties; board chairman; developer; civic leader and philanthropist.

Mr. Huggins founded his business in 1975 as Riteway Painting and Decorating, Inc. As a painting and decorating contractor, he was recognized for his innovative ability to envision and form a tri-venture partnership on construction projects at O'Hare Airport for United Airlines. The company went on to participate in every major construction project at O'Hare in the 90's including Delta, Northwest, and the New International Terminal. With Huggins at the helm, the company evolved into Riteway Construction Services, Inc. in 1985 and began to provide construction management, concrete, and development services. In 2006, the firm emerged into the name it bears today, from its founder, Riteway-Huggins Construction Services, Inc. adding trucking to its repertoire of services.

Riteway-Huggins Construction has performed numerous large-scale projects including: Exelon Solar Project in West Pullman, John H Stroger Jr. Hospital, AT&T Corporate Center, McCormick Place South expansion, Unicorn Thermal Technologies Cooling Plant, United Center, and the newly completed 31st Street Harbor along the Chicago lakefront. In addition, the firm served as the Construction Manager for the 1996 Democratic National Convention.

Business acumen and civic leadership have twice placed Larry Huggins in the role of Chairman. In May 2009, Huggins was elected Vice-Chairman of the Commuter Rail Board (Metra) by a unanimous Board vote, and he served in that role until his term expired in November 2012. Larry Huggins was appointed to the Metra Board in 1997 by the City of Chicago where he served as one of the longest serving members until his term expired in 2012. Most recently, he served as Acting Metra Chairman from April 2011 to November 2012. Larry Huggins is also chairman of Granite Development Master Corporation, an African-American owned development firm he co-founded with Joseph A. Williams. Since



1995, Granite Development has been involved with projects such as: the historic Reliance building redevelopment into The Hotel Burnham, a European-style boutique hotel in downtown Chicago; Auburn Lake Homes, 19 single family duplex homes in Chicago's Auburn/Gresham neighborhood; Jazz on The Boulevard, a mixed-income residential complex on Chicago's Southside. Granite's largest project to date is in partnership with Oakwood Boulevard Associates; upon completion the project will consist of 3000 mixed-income residences.

Larry Huggins has been honored with numerous recognitions; receiving top civic and industry awards for advocacy and advancement of economic opportunities for minorities. Most recently Mr. Huggins was honored by Chicago Defender newspaper by receiving the first Robert S. Abbott Humanitarian Award in 2016 for his philanthropic endeavors as the founder of Christmas in the Wards and in 2012 he also received the Newsmaker of the Year for Transportation award by the Chicago Defender newspaper for his efforts in providing fair and equitable transportation for all Chicagoans. In the mid 90's he was featured in Newsweek and Ebony magazines, detailing his path and that of minority firms striving to flourish in the construction industry. He is a founding member of Black Contractors United (1979), serving as the organization's vice president in 1987 and was named Contractor of the Year by the group in 1986 and 1997. In 1981, he received the annual Bronze Hard Hat Award from the Chicago Economic Development Corporation in recognition of the firm's achievements, performance, and growth as a minority-owned construction firm. Amongst many accolades, Mr. Huggins has twice received recognition by the Chicago Urban League (1990 and 1991), was twice named Outstanding Contractor by the Coalition for United Community Action (1992 and 1994) as well as Contractor of the Year by the group in 2000. In 1995, he received an Exemplary Entrepreneur Award from Bank of America and in 1996 he was named Minority Contractor of the Year by the Chicago Department of Transportation. He was also named Contractor of the Year for the Grant Park Museum Campus Project in 1998; Business Man of the Year by the African American Contractors Association; Entrepreneur of the Year by the QBG Foundation and Citizen Newspaper.

Through Riteway-Huggins, he has championed many philanthropic endeavors. His community service contributions were recognized by the Inner City Youth Council (1993 and 1994). In 1998, Huggins started a non-profit organization; The Christmas in Englewood Foundation. For 12 years, the program brought smiles, joy, and laughter to thousands of Englewood families and children through giving partnerships, and garnered support from community and political leaders raising over 1 million dollars. In 2011, the foundation reorganized to form Christmas in the Wards and has committed its resources to support and serve families in the 8th and 34th Wards of Chicago's south-



side. In 2016, Christmas in the wards expanded to serve all under-privileged communities on both the south-side and west-side. Also in 1998, Mr. Huggins and his partners formed the Chicago Football Classic, an organization that endeavors to offer college scholarships and promote academic excellence to Chicago's underserved youth. Since its inception, Chicago Football Classic has successfully awarded several hundred thousand dollars in academic scholarships and is supported by Chicago Public Schools and endorsed by the City of Chicago.

Todd is the CEO and Founder of Bunker Labs, a national entrepreneurship organization dedicated to helping military veterans start and grow businesses. Announced in June 2014 at 1871, Chicago's Tech Entrepreneurship Hub, Bunker Labs has grown to locations in several other cities through a chapter affiliate model, with further expansion plans underway.

The Bunker Labs works to support military veterans by creating locally thriving networks, robust educational programs, and platforms for military veteran entrepreneurs to connect with the people and the resources they need to be successful with early stage ventures. The newest innovation is the "Bunker In A Box", an online gamification approach to entrepreneurship education for current and former servicemembers.

Todd Connor is a former management consultant, U.S. Navy veteran, and has held many leadership roles in the public and private sector. He is a two-time entrepreneur and the founder of Flank 5 Academy. Todd holds a BA from Northwestern University, an MBA from the University of Chicago previously served as a Senior Administrator at Chicago Public Schools, and is the author of two books on leadership and personal strategy. He is a Commissioner of the Cook County Commission on Human Rights, was honored as a 2015 Crain Chicago Business 40 Under 40, winner of the Chicago Inno 50 on Fire award and is a 2016 Presidential Leadership Scholar.

Dennis Chookaszian is the retired chairman and chief executive officer of CNA Insurance Companies.

Mr. Chookaszian served as CNA's chairman and chief executive officer from 1992 until 1999. He also served as chairman of the executive committee of CNA from 1999 to 2001. From 1990 to 1992, Mr. Chookaszian served as CNA's president and chief operating officer, with responsibility for all property and casualty, life, health and investment operations. Mr. Chookaszian joined CNA in 1975 and served as chief financial officer until 1990 when he was named president. He also served as chairman and CEO of mPower Inc, an internet financial advisory service, from 1999 to 2001. Mr. Chookaszian served as chairman of FASAC (Financial Accounting Standards Advisory Council) which provides guidance to the FASB (Financial Accounting Standards Board) on accounting matters for five years and completed his term in 2012. He was also a member of the FCAG (Financial Crisis Advisory Group) which was the international commission that was created to develop recommendations to solve the financial reporting problems associated with the financial crisis of 2008.

During his career, he has served as a director on the boards of thirteen publicly traded corporations and fifty private corporations. He is currently a director of four public companies including the Chicago Mercantile Exchange, the world's largest financial futures and derivatives exchange, Career Education, a private post-secondary education provider, Maxar Technologies, a space satellite technology company, and Pillarstone Capital, a real estate investment trust. He also serves as a director of a number of private corporations and has served as an arbitrator in eleven diverse cases and as an expert witness in twelve cases.



Mr. Chookaszian is an Adjunct Professor at the University of Chicago Booth School of Business and teaches courses in Corporate Governance. He also teaches a course in International Corporate Governance at Cheung Kong University in China, Shanghai Advanced Institute of Finance in China, and at IIPM in India.

Mr. Chookaszian is a trustee of Northwestern University, a member of the advisory board of the University of Chicago Booth School of Business, and a member of the advisory board of Kellogg Graduate School of Management. He is also a member of the national board of the Boy Scouts of America, a director of Northwestern Memorial Foundation and president of the Foundation for Health Enhancement.

Mr. Chookaszian has a bachelor's degree in chemical engineering from Northwestern University, an MBA from the University of Chicago Booth Graduate School of Business, and a master of science degree in economics from the London School of Economics. Other international efforts brought Mr. Goluska to Spain, Germany, Hungary, Czechoslovakia, the Middle East and the Far East.

With a strong focus on major urban developments, Mr. Goluska as an SOM Partner directed the master planning and conceptual development of several of the most significant planning initiatives in Chicago in recent history: the proposed Lake Calumet International Airport, the \$2 billion proposal for a casino/entertainment center in downtown, and the master development plan for the 1995 South Hall and 2005 West Hall of Chicago's McCormick Place complex.
