INDOT DISTRICT MEETINGS – STATEWIDE TRANSPORTATION IMPROVEMENT PROGRAM

The Indiana Department of Transportation (INDOT) engages in a proactive and continuous public involvement process during all phases of development, including planning and continuing through construction. However, prior to the delivery of a proposed project, INDOT must first coordinate planning, programming and project selection activities with a variety of key transportation stakeholders. The purpose of this coordination is to develop a listing of projects for consideration, evaluation/screening and upon approval, inclusion into the Statewide Transportation Improvement Program (STIP).

The STIP is a four-year planning document that lists all projects expected to be funded during those four years, including pavement and bridge facilities, in addition to projects that address safety, congestion, mobility and emergency response. The STIP includes investment in a variety of transportation modes, including highways, transit, pedestrian trails, multi-use paths, and bicycle facilities.

INDOT is hosting a series of public open houses to present and also accept comment with regard to the STIP. Each open house is an opportunity to learn what projects are listed in the STIP (fiscal years 2018 – 2021) and what projects are programmed in your community. A primary objective of each open house is to receive feedback on how local transportation needs may be better served by INDOT.
