**Q: Do you need to be a member ISPE to submit an abstract?**

A: No.

**Q: Are figures or tables allowed in the abstract submission site**

A: *The abstract submission site accepts text only with a maximum of 500 words.*

**Q: Do I have to be a student to submit an abstract?**

A: *For the ISPE Mid-Year meeting, only students and recent graduates (up to three years post-graduation) may submit abstracts.*

**Q: Can the presenting author be affiliated with industry?**

A: *Yes, the presenting author can be affiliated, but they must disclose that on the conflict-of-interest form.*

**Q: Can one person be listed as the presenting author on more than one poster/oral presentation?**

A: Yes.

**Q: Are the abstracts embargoed?**

A: *All accepted abstracts are embargoed until April 1, 2024.*

**Q: Does the ISPE Mid-Year meeting accept encore abstracts?**

A: No.

**Q: Does ISPE Mid-Year meeting accept later-breakers?**

A: No.

**Q: Does ISPE publish accepted abstracts?**

A: *Accepted abstracts will be published in Pharmacoepidemiology and Drug Safety (PDS), on the ISPE website, and in the meeting app for this event.*

**Q: I submitted my abstract but now I want to make edits; can I?**

A: *You can access and edit your abstract until the process closes at the published deadline. Login to the abstracts process via the same link using the credentials you entered when you created your account.*

**Q: If my abstract is accepted can I make edits?**

A: No. *Edits will not be accepted after acceptance notices are issued.*

**Q: Can I add co-authors to my submission after acceptance?**

A: No. *Role changes (presenting author or co-author) are permitted only with individuals already associated with an abstract at the time of final submission.*

**Q: Do I have to register for the meeting to present my abstract?**

A: Yes

**Q: Can I present my abstract virtually?**

A: No. *The ISPE Mid-Year meeting is a live event and accepted abstracts must be presented in person in Orlando.*

**Q: Do you accept abstracts that have been or will be presented at other national or international congresses?**

*A: Results that have not been published (not in abstract form) either on-line ahead of print or in printed version before October 1, 2023, will be accepted. Results that have been published (except in abstract form) either on-line ahead of print or in printed version before October 1, 2023, are NOT eligible for submission. Results that have been presented at meetings of other societies are eligible, provided they have not been published (except in abstract form) either on-line ahead of print or in printed version before October 1, 2023.*
