Leslie Sutherlin currently serves as the District Library Media Specialist at South Dearborn Community Schools in Aurora. Though she started as the high school media specialist in 2004, due to attrition, her responsibilities have gradually expanded to include all buildings

in the district. Prior to her work in the library, she taught high school English at Greenfield-Central and South Dearborn and coached volleyball for 13 years. In ILF, she served as President of AISLE in 2013 and has been active in ILF in many capacities, including the Eliot Rosewater and YHBA Committees, Silent Auction Chair, Conference Committee member, Legislative/Advocacy Committee, AISLE District representative, and Indiana representative on the Council of State School Library Supervisors (formerly NASTEMP). Outside of ILF, Leslie served on Glenda Ritz's Hoosier Family of Readers, and more recently, Leslie was selected for the Indiana State Library Leadership Academy. She has been an NEA Learning and Leadership grant recipient, an LSTA grant recipient and later a grant reviewer, and she has been published in *School Library Monthly* in an article co-written with Marge Cox and Linda Mills.

Committed to improving her community, she is a member of Aurora Tri Kappa, St. Paul Lutheran Church in Milan, and Milan High School Soccer Boosters. She serves as the chair of the Score for Scholars program for Milan Community Dollars for Scholars, as well as Milan Middle School PTO. LATRICE BOOKER, AT-LARGE CANDIDATE



Latrice Booker has worked as the Interim Director of Library Services at Indiana University Northwest since July 2017. Previously, she worked as the Coordinator of Library Instruction at Indiana University Northwest beginning in 2008 and received tenure in 2014.

Latrice began working at IU Northwest as an undergraduate student worker in the Circulation department.

After graduating with her Bachelor's degree in Spanish, she did not want to leave the library. A librarian told her about the Master of Library Science degree, and Latrice enrolled in the master's program at Indiana University-Purdue University at Indianapolis. She received her MLS from Indiana University in 2006 and Master's in Business Administration from Indiana University Northwest in 2012. Latrice is currently pursuing a Doctorate degree in Instructional Systems Technology from Indiana University Bloomington. She is very active in library associations, including serving as a Board Director-at-Large for the Indiana Library Federation, Councilor-at-Large for the American Library Association, past co-chair of the Association of College and Research Libraries Scholarships Committee, past chair for the ILF District 1 Planning Committee and past President of the Indiana University Librarians' Association. Latrice was also a 2009 ALA Emerging Leader and is a member of the Black Caucus of the American Library Association.

FONDA OWENS, PUBLIC LIBRARY REPRESENTATIVE



Fonda Owens is the director of the La Porte County Public Library, which is a multi-location library system with a service population of 65,000+. The library employs 54 FTE and has an annual budget of about 5.5 million dollars. She began as director in November of 2011 and prior to that was the Extension Services Manager beginning in January

2003. Before moving to La Porte, Fonda worked in public libraries in Alabama and Virginia. Over the course of her career, she has worked in circulation, youth services, technical services, outreach services and administration. She is a current member of ILF and in past years has been a member of ALA and PLA. The library is an institutional member of ILF and ALA.

Fonda's focus over the last five years has been on building and maintaining community relationships. The result of that focus has been the successful effort to get a \$12 million bond approved by the County Council. The bond funds were used to build four new facilities and extensively renovate three other buildings. The work at the Main Library has won an architectural award for design and most importantly, the community loves the new facilities. Another outcome has been a deeper collaboration between the library and the school corporations for new library services for students and teachers. This is called Libraries 360. The end result of the service is over 15,000 students and their teachers have LPCPL cards and materials are delivered to schools for their use.

Fonda is an active participant of the La Porte Chamber of Commerce as a member of their Governmental Affairs (2011 to Present) and the Business Retention (2017 to Present) Committees. She also represents the library on Skill Up!, which is a county-wide career readiness initiative led by the Department of Workforce Development. Fonda has been a member of the Rotary Club of La Porte since 2012, where she serves on the Rotary's Board of Directors and is active with Women in Leadership La Porte County, having served on their Board of Directors since 2017.

Fonda has three wonderful children, who have helped her grow and mature in ways that she cannot fully explain but she deeply appreciates their contributions to the person she has become. Fonda knows they will continue to keep her on her toes!

Before USC, Ms. Hostetler worked for two years as Public Services Librarian at Hollins University, a liberal arts university for women in Roanoke, VA.

Ms. Hostetler earned a BA in Sociology, a BA in Psychology, as well as her MLS from Indiana University in Bloomington.

Ms. Hostetler has served as a board member for the Indiana Library Federation (ILF) since 2017 and is a member of ILF's Awards and Scholarships Committee and its Indiana Academic Library Association Advisory Board. She was a board member for the Academic Libraries of Indiana (ALI) from 2014-2017, serving on the Self-Administration Task Force (2015-2016) and the Board Nominating Committee (2016-2017). Ms. Hostetler is a member of the American Library Association's Library Leadership and Management Association (LLAMA) and served on LLAMA's Library Organization and Management Section's Financial and Administrative Services and Leadership Development Committees from 2013 to 2015. She has served as a mentor for young library professionals for both ILF and LLAMA.

On the USI campus, Ms. Hostetler serves as a member of Provost's Council, the Academic Planning Council and the Center for Communal Studies Board. She is an Ex Officio member of USI's Council of Graduate Program Directors and Chairs, and Faculty Senate's standing Assessment and Faculty and Academic Affairs committees.

Statement: As someone who spent many years as a librarian outside of Indiana, joining ILF and serving as a board member has been a great learning opportunity. I have seen many changes in my 20+ years as a librarian and this is an exciting time to be in the profession. I am still learning about ILF and Indiana libraries, and I look forward to continuing to contribute in any way I can.

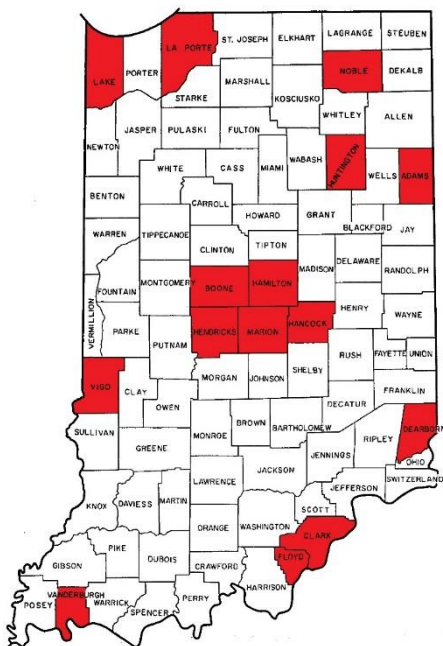
DAVID PETER, TRUSTEE / SUPPORTER REPRESENTATIVE
