PLEASE ACCEPT THIS AS A NOTICE TO INFORM YOU, as a property owner, tenant or interested citizen, that the Council of The City of San Diego, California will conduct a public hearing, with two actions, as part of a scheduled City Council meeting, on the following project:

ACTION 1:

Council to consider approving or denying a request for reconsideration of the All Peoples Church, Project No. 636444 which was before the City Council on January 9, 2024 with an application for a General Plan/Community Plan Amendment; Planned Development Permit; Site Development Permit; Tentative Map; Revestment of Access Rights; and Easement Vacations to allow for the construction and operation of a 54,476-square-foot (SF), two-story church/sanctuary building and a 71,010 SF, two-level parking garage and surface parking areas on an approximately 5.99-acre site. The church use includes a 900-seat sanctuary space with accessory uses (i.e., Sunday school classrooms, offices, and a multi-purpose room/gym), and various site improvements, such as a traffic signal, hardscape improvements, landscaping, and utility connections. City Council previously voted to not certify Environmental Impact Report (EIR) No. 636444/SCH NO. 20211100394 and Mitigation Monitoring and Reporting Program (MMRP) and denied the project, on a 6-2 vote.

ACTION 2:

If the request to consider is approved, City Council will reconsider the application for a General Plan/Community

Plan Amendment; Planned Development Permit; Site Development Permit; Tentative Map; Revestment of Access Rights; and Easement Vacations to allow for the construction and operation of a 54,476-square-foot (SF), two-story church/sanctuary building and a 71,010 SF, two-level parking garage and surface parking areas on an approximately 5.99-acre site. The church use includes a 900-seat sanctuary space with accessory uses (i.e., Sunday school classrooms, offices, and a multi-purpose room/gym), and various site improvements, such as a traffic signal, hardscape improvements, landscaping, and utility connections. The project site is currently unaddressed and undeveloped, located northeast of the College Avenue/Interstate 8 interchange, south of Del Cerro Boulevard, within the RS-1-7 Base Zone, the Airport Land Use Compatibility Overlay Zone (Montgomery Field), Airport Influence Area (Montgomery - Review Area 2), Sustainable Development Area, Parking Standards Transit Priority Area (Campus) within the Navajo Community Plan area.

Environmental Impact Report (EIR) No. 636444/SCH NO. 20211100394 and Mitigation Monitoring and Reporting Program (MMRP), has been prepared for the project in accordance with State of California Environmental Quality Act (CEQA) Guidelines. The EIR found potentially significant impacts in the areas of Biological Resources, Historical Resources, Noise, and Tribal Cultural Resources. An MMRP would be implemented that would reduce impacts to below a level of significance associated with Biological Resources, Historical Resources, Noise, and Tribal Cultural Resources.

The decision of the City Council is final.
