Dear Vendors:

The following are the 2022 Application and Vendor Rules for Hudson Old Home Days which will be held on Thursday, August 11 through Sunday, August 14.

Please be completely aware that Hudson Old Home days is a **four day event**. Vendors must be open and onsite for all four days. **Homemade Craft vendors, once approved by committee can be only set-up Friday, Saturday & Sunday** Please read the vendor rules sheet for a complete listing of set-up times and hours of operation. Please read the Vendor Rules as they have been updated and/or modified.

Electricity is included in your space fee. However, you must bring your own grounded extension cord of at least 100 feet or more. Any light bulbs must be covered as well; no bare or exposed bulbs are allowed per the electrical code.

Special Electrical Need: If you require specific electrical hook ups or equipment, you must schedule an appointment and hire your own NH Licensed Master Electrician, per the Hudson Fire Department and State of NH. **You hire your own licensed electrician at your own expense.**

You also provide your own tent/shelter, tables and lighting (again, light bulbs must be covered). All tents must be staked into to the ground and be anchored within the selected space. This is a rain or shine event. Certificates of Insurance may be requested.

Applications and Deposits should be sent early to reserve your spot. Final Payments are due by July 31st.

Again, this year we have a procedure for those wishing to put on demonstrations. Spaces will be filled on a first come, first served basis. For every 30 minute spot (which includes set-up and take down) there will be a \$20 fee. You do not need to be a vendor to do a demonstration.

We sincerely hope to see all the old faces and some new ones this year at Hudson Old Home Days.

Wednesday, August 10 by appointment* (trailers only)

Thursday, August 11 - 10:00 to 3:30 pm (all vendors)

- Trailers must set up on Wednesday with an appointment.
- Vendors with special electrical requirements contracting our hired electrician must set up an appointment for Wednesday.
- NO other vendors should be setting up on Wednesday except trailers.

Vendor Rules and Regulations

1. Original Certificate of Insurance must accompany application if applicable (food vendors or items that may be consumed or products that have a potential for adverse skin reactions. Please contact us in advance of sending in application if you are unsure a Certificate of Insurance is required.
2. When choosing site size, you must include any trailers, trailer hitches and doors that open out in requesting space size. You must have enough room in your paid space. You must state on application that you are bringing a rig or trailer for placement purposes. **ALL** rigs and trailers must be set up Wednesday.
3. Vendors **must** participate in all **four** days of the event (Thursday, Friday, Saturday, and Sunday)
Homemade Craft vendors, once approved by committee can be only set-up Friday, Saturday & Sunday
4. Vendors **must** provide their own tent (tents must be staked into the ground and be anchored within the selected space), table(s) and a minimum of 100 foot **grounded** extension cord(s). **None** will be provided.
5. **Electrical code** requires the following: All light bulbs must be covered (cannot be bare) and extension cords must be grounded. Anyone not using a **grounded** extension cord or covered light bulb will be disconnected from electric until the proper cord and/or light cover is in use. Special Electrical hookups or equipment will require a hired electrician per the Hudson Fire Department- you must hire your own licensed electrician.
6. The OHD Committee will determine vendor location. Vendors **must** clean up rented area nightly before leaving site. Confetti or garland is not allowed. Each vendor is responsible for cleaning up their space prior to final departure on Sunday. The field is used for hay for animals and trash and/or other litter may be hazardous to the animals.
7. Vendors must stay WITHIN assigned areas. You must sell or promote from **within** your space. We do not allow walk-around vendors. We do not allow vendors to approach the public in public pathways. Vendors who violate this rule will be asked to leave the premises for the remainder of the weekend. ALL space rental and electrical fees will be forfeited.
8. No products are to be sold or given away without prior approval by the Hudson Old Home Days Comtt.
9. Carnival has exclusive rights to sell fried dough, sausages, popcorn, cotton candy, and candy apples.
10. **ABSOLUTELY NO** personal vehicles are allowed on site during Hours of Operation. Vehicles must be removed from the grounds a MINIMUM of **30 minutes prior** to opening each day. Vehicles **may not** re-enter grounds until **15 minutes after** closing each day.
11. **NO PETS** allowed on fairgrounds. This includes during setup and prior to operating hours.
12. This is a rain or shine event. 50% down payment is nonrefundable should you choose not to participate. NO security on site overnight. The Hudson Old Home Days Committee reserves the right to refuse any application for reasons including but not limited to: appropriateness, duplication, failure to pay fees in total and/or failure to supply insurance.
