Eligible participants and program deadlines:

This program is eligible for a licensed independent Goodman Heating and Air Conditioning Dealers in the U.S. The 5% standard buy-downs will run year-round, but claims must be submitted by the end of each quarter per the guidelines below.

- U.S. Homeowner must purchase eligible equipment and execute a consumer financing contract with an Goodleap lender between **January 1, 2024, and March 31, 2024.**
- Licensed independent dealer must install qualifying equipment between **January 1, 2024, and March 31, 2024.**
- All consumer financing contracts must be funded by Goodleap by **April 15, 2024.**
- All buy down rebate claims must be submitted by **April 15, 2024.**
 - Late claims will be paid out at 50% of the dealer rebate amount only for a short period after the initial deadline.
 - Any late claims will be paid at Goodman Manufacturing's discretion.
 - Rebate amount cannot exceed dealer fee

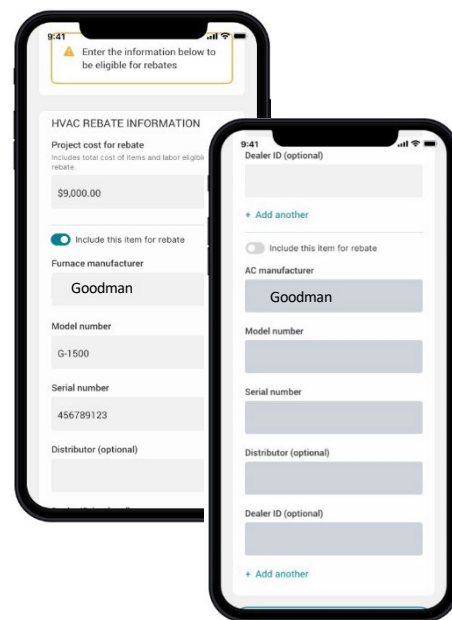

Simply enter the model and serial number, (and dealer ID if applicable), in the designated fields. Click "add another" if you have sold additional qualifying units.
