- This program is eligible for a licensed independent Goodman Heating and Air Conditioning Dealers in the U.S. The standard buy-downs will run quarterly. Claims must be submitted by the end of each quarter.
- U.S. Homeowner must purchase eligible equipment and execute a consumer financing contract with an Goodleap lender between **April 1, 2024, and June 30, 2024.**
- Licensed dealer must install qualifying equipment between **April 1, 2024, and June 30, 2024.**
- All consumer financing contracts must be funded by Goodleap by **July 15, 2024.**
- All buy down rebate claims must be submitted by **July 15, 2024.**
- Late claims will be paid out at 50% of the dealer rebate amount only for a short period after the deadline.
- Any late claims will be paid at Goodman Manufacturing's discretion.
- Eligible installations need not include a complete "system".
- **Rebate amount cannot exceed dealer fee.**
- **Must be enrolled and active on Goodleap's financing platform to qualify.**



1. Select “Verify Project Info.”
2. Scroll to select Goodman as the manufacturer of the type of equipment. Then enter AFUE or SEER.
3. Once you have marked the project as “Installation Complete” on your timeline, you will be prompted to proceed with the financing buy-down process.
4. Simply enter the model and serial number, distributor and dealer ID in the designated fields.
5. Click “add another” if you have sold additional qualifying units.
6. Select “Save and Continue.”

It's that simple. You will receive a wire in 7-10 business days for the eligible equipment rebate.
