- **Middle District of Florida:** the JNC will select and submit three (3) finalists for U.S. Attorney and three (3) finalists for U.S. Marshal.
- **Southern District of Florida:** the JNC will select and submit three (3) finalists for U.S. Attorney, three (3) finalists for U.S. Marshal and six (6) finalists for U.S. District Judges.

Following an applicant's submission of an application to a FL JNC District Conference, the applicant is prohibited from contacting members of any FL JNC District Conference regarding any aspect of the applicant's candidacy except in response to inquiries received from a District Conference Chair.
