MINUTES OF THE 2/19/2023 ANNUAL MEETING

- 1. **CALL TO ORDER & OPENING PRAYER**: Senior Warden **Chris Dee Eggert-Rosenthal**, presided. The meeting took place in the Sanctuary and was called to order at 11:20AM with a quorum present.
- 2. **2022 ANNUAL REPORT:** 3/6/2022 Annual Meeting minutes; Official Acts; Reports from the Clerk, Rector, Wardens, and Worship Coordinator; other reports; and 2022 financials.
- 3. **2022 MINUTES:** Minutes from the 3/6/2022 Annual Meeting were reviewed. A motion was made and seconded to approve the minutes with special thanks to Clerk Tony Karl; motion carried.

4. **2023 ELECTIONS:**

- a. **Endowment Fund Trustee** (two positions; a full 3-year term and a partial term following Hugh Foster's death): **Mike Laughrin** (2023) and **Sherry Paszkiewicz** (2023-2025) were nominated during the nomination period. No nominations from the floor.
- b. Lay Delegate to Diocesan Convention (two positions; 1-year terms): Eleanor Agnew and Ron Hansen were nominated during the nomination period. No nominations from the floor.
- c. Lay Alternate to Diocesan Convention (two positions; 1-year terms): Marian Doszkewycz and Nick Doszkewycz were nominated during the nomination period. No nominations from the floor.
- d. **Voting:** With one nominee for each required position, a motion was made and seconded to close nominations and elect the complete slate of candidates; motion carried.
- e. **SPECIAL NOTE:** Per diocesan guidance as we begin our transition the current Vestry will stay in place throughout 2023 (no elections for Wardens or Vestrypersons).
- 5. **TRANSITION PROCESS UPDATES:** The Vestry and Search Team gave updates on the first phase of our clergy transition following **The Rev'd Diane M Murray**'s retirement on 12/31/2022.
- 6. **REVIEWED FINANCIAL REPORTS & BUDGETING PLAN:** Year-end financials were included in the report. The 2023 budget is still being adapted to reflect our transition. The congregation was invited to give feedback and ideas.
- 7. **RECOGNIZING THOSE WHO ARE COMPLETING, CONTINUING, OR BEGINNING MINISTRY ROLES:** *In addition to those elected at this meeting, we extended our appreciation to these people.*
 - a. **Vestry: Chris Dee Eggert-Rosenthal** and **Mary Green** served as Senior Warden and Junior Warden. **Nick Doszkewycz, Joan Estes,** and **Tony Karl** served as Vestrypersons.
 - b. **Trustees: Eleanor Agnew** is continuing a 3-year term (2022-2024). **Mike Laughrin** completed a 3-year term and was re-elected to a partial term (2023--**Hugh Foster** passed away during his term). **Sherry Paszkiewicz** was elected to a 3-year term (2023-2025).
 - c. Convention Delegates & Alternates: Mike Laughrin & Sharon Laughrin were our 2022 Delegates; Mary Green, Chris Eggert-Rosenthal, Eleanor Agnew, & Ron Hansen were our Alternates (we ended up with extra alternates due to change in diocesan delegate counts).
 - d. Officers elected by the Vestry: Tony Karl just completed his 9th year serving as our Clerk. Linda Molitor has served as our paid Treasurer since Fall 2021.
- 8. **CELEBRATIONS & GRATITUDES:** Everybody was invited to share celebrations and gratitudes about our congregation in the past 12-15 months and moving into the future together.
- 9. **ADJOURNMENT** & **CLOSING PRAYER:** Business being concluded at 12:05PM, a motion was made and seconded to adjourn the meeting; motion carried.

RESOLUTION REGARDING 2024 CONVENTIONS

The Diocese of Fond du Lac has issued the following guidance...

Important Announcement about Electing Lay Delegates at Annual Meetings

Most congregations in the Diocese of Fond du Lac hold an annual mee ng in January/February. One regular item of business is election of lay delegates to the Annual Diocesan Convention. As explained here, your congregation should NOT elect such lay delegates.

- 1. A Special Convention will be held May 4, 2024. Diocesan Canon 1.4 is clear that its lay delegates are those certified to the most recent Annual Convention (2023 in Menasha). If any of those lay delegates are unable to attend, then they may resign those elected alternates may be appointed. It is possible that a congregation may run out of alternates or may not have elected such.
- 2. Whether there is reunion or not, there is a need for lay delegates to the next Annual Convention (Fond du Lac/ Wisconsin). Details of election to a Wisconsin Convention have not been determined, but we know lay delegates will be needed.

Based on these two issues and to assure appropriate representation from each congregation, the annual meeting should pass the following resolution:

Whereas, diocesan Canon 9 allows the annual meeting to authorize other forms of election of lay delegates than its action, and;

Whereas, it is possible lay delegates and alternates certified to the 2023 Annual Diocesan Convention may be unable to attend the 2024 Special Convention, therefore be it:

Resolved, that the Annual Meeting of St James Episcopal Church, Manitowoc, authorizes the Transition Pastor and Wardens to fill a lay delegate vacancy to the Special Convention, first from the alternates previously elected or second, from qualified lay members if no alternates remain, and be it further

Resolved, that the Annual Meeting of St James Episcopal Church, Manitowoc, authorizes the Vestry to elect the appropriate number of lay delegates to the 2024 Annual Convention.

Your St James Episcopal Church Vestry met or Zoomed for prayer, study, discussion, and planning throughout the year, in regular meetings, special meetings, and retreats. Dates and highlights include:

- 1/10/2022 Special Meeting: Initial meeting of full Vestry and Mother Meredyth Albright, our Diocesan Transition Minister; overview of process—1-2 years is common now; she gave us guidance on assembling Search Team, Vestry discerning Search Team candidates to invite.
- 1/24/2022 Regular Meeting: started with Mother Meredyth, who helped us review and finalize our order to invite Search Team candidates; approved \$500 for CARElink program; Linda is wrapping up 2022 financials, we're still discerning options to proceed in 2023; Annual Meeting planning, Tony will assemble the report; homeless to be discussed next Congregational Chat; at next Vestry Retreat we'll start to figure out parish inventory.



- 1/31/2022 Five accepted our invitation, so we have a Search Team; will announce.
- 2/14/2023 Special Meeting: transition updates; reviewed plan to get written feedback and ideas from the congregation to help in our further budget planning; finished planning Annual Meeting.
- 2/21/2023 Began putting together plan for pastoral support during our transition.
- 2/28/2023 Voted to call The Rev'd Brian Staude as our Transition Pastor effective 4/1/23; various building work; Mark & Sally Hunner assembling Stewardship Team; planned for Vestry retreat.
- March 2023 Regular meeting and retreat postponed as we finished preparing for Pastor Brian.
- 4/11/2023 Regular Meeting: discussed intentional language use; re-scheduled retreat; reviewed and approved 2022 Parochial Report; reviewed congregational feedback on budget, finalized, and approved our 2023 budget.
- 4/25/2023 Special Meeting: discussed report from Stewardship Team; reviewed Dedicated Funds.
- 5/2/2023 Vestry Retreat: Heard and approved proposal for Connect & Engage ministry; building and property walk-around; approved \$500 sponsorship of 7/29 Lakeshore Pride event and having a table; discussed inventory project; made plan for Vestry book discussion and teambuilding.
- 6/6/2023 Special Meeting: book discussion and teambuilding facilitated by Pat Hanson.
- 6/27/2023 Regular Meeting: received June report from Connect & Engage and approved recommendations (begin forming ministry related to greeting/welcoming visitors; \$500 marketing expense budget for promotion and giveaways for Lakeshore Pride and following events; approve conclusions in target audience investigation report); Stewardship Team update.
- 7/17/2023 Special Meeting: book discussion and teambuilding facilitated by Pat Hanson.
- 7/25/2023 Regular Meeting: updates from Connect & Engage, Search, and Stewardship; beginning to add new money counters to rotation; accepted Joan Estes' resignation as Vestryperson; ordered new ambo and lectern for increased safety.
- 8/21/2023 Special Meeting: book discussion and teambuilding facilitated by Pat Hanson.
- 8/22/2023 Regular Meeting: Connect & Engage update; authorized Eleanor Agnew to write a grant proposal for St James from The Wisconsin Board for People with Developmental Disabilities, to help St James become a more accessible church for people with disabilities and their families/caregivers so they will feel welcomed and involved; fixed kitchen wiring; various building issues.
- 9/12/2023 Special Meeting: accepted Dave Haefke's resignation as Sexton; decided to order a defibrillator this Fall.
- 9/25/2023 Special Meeting: Vestry "Defining the Win" facilitated by Pat Hanson.
- 10/10/2023 Special Meeting: various building updates; discussed Sexton vacancy.

- 10/24/2023 Regular Meeting: Eleanor Agnew presented about the \$5000 grant she received for St James from The Wisconsin Board for People with Developmental Disabilities; Connect & Engage updates; training an additional money counter; Began discussing how to implement the Vestry's "Defining the Win" results.
- 10/28/2023 Email Meeting: approved revised Sexton position description.
- 11/6/2023 last session of teambuilding facilitated by Pat Hanson; identified areas our leadership team and congregation can work on to continue to grow and thrive moving forward.
- 11/28/2023 Regular Meeting: received, reviewed, and accepted the 2022 Report of Financial Review and Summary of Actions (annual diocesan financial review); approved increasing Treasurer Linda Molitor's 2023 compensation due to additional time spent on her tasks; begin to plan for consulting work with ChurchWerkes; approved \$14,062 pledge to diocese; approved \$9,324 distribution from Diocesan Common Trust for 2024; Stewardship planning; Advent deliveries/cookies planning; Nick & Marian Doszkewycz began serving as our Sextons on a voluntary basis starting in November; scheduled Annual Meeting and began planning.



- December 2023 The Vestry did not meet or conduct business.
- 1/3/2024 Regular Meeting: made another Stewardship plan; approved 3% compensation increase for Pastor Brian; approved \$3000 for initial phase with ChurchWerkes; Annual Meeting planning; prepared nomination report/form; AED (defibrillator) was installed; other building projects.
- 1/23/2024 Special Meeting: Approved 42% compensation increase for Treasurer Linda Molitor; approved reallocating \$16,510.96 from Dedicated Funds (\$2,123 from Outreach Fund, \$12,000 from Technology Fund, and \$2,387.96 from Youth Ministry Fund) to be used for our 2024 operations.
- 2/13/2024 Regular Meeting: final Annual Meeting preparation.

As you can see, your St James Vestry has been quite busy the past year!

On a personal note, it has been a privilege to serve our congregation as Clerk for the past 10 years. My Vestryperson term ends following our 2024 Annual Meeting; I have decided now is a good time for me to rotate out of the Clerk position, as well. I am grateful for all that I've been able to learn from and share with the many wonderful siblings in Christ on the Vestry over the years. Thanks especially to the team that has been working so hard this past year, and for the invaluable help Pat Hanson gave us. 2023 surprised us in some ways we didn't anticipate or expect, and we have all grown stronger as a result.

I look forward to the continued renewal our congregation will experience through our ongoing collaboration with ChurchWerkes. Episcopalians first began meeting in Manitowoc in 1841, and that wonderful legacy continues! I remain excited and optimistic about our St James church family and all that God has in store for our future.

It seems appropriate to start this way again. 2023 was a Year of Learning. We aren't kidding—"we didn't know what we didn't know." There were things left undone or missed. We put our hearts and energies into making this transition smooth. We made it through the year, and we are stronger in Faith for the learning and struggles. The Vestry learned together this year. We learned that many duties were not well-defined and were not evenly distributed. We were fortunate that Tony Karl has been at St James so long and could fill us in on what needed to be done and indeed did much of the work needed. Communication, work division, and a strong desire to have everything in place for our next Rector had us reach out for some additional advice and we have started working with

the consulting group ChurchWerkes to help us clearly define roles and have up-to-date job descriptions, among other things. There will be updates on this soon.

Pastor Brian Staude has been a blessing to all of us and has added so much to our St James family. He is participating in many diocesan events and learning much more about The Episcopal Church. He has also brought fresh ideas in his sermons and outreach. We are grateful for him. The 2024 budget projects another deficit and we know we need new ways to support our church. We have faithful members who continue to support our family to best of their capabilities. We continue to be available with multiple hybrid opportunities to worship and share community.

St James activities are open to all. At St James, membership is not a participation requirement for any of our opportunities (other than elected leadership):

• Our Friday Morning Prayer group meets with joyful praises and indeed sometimes there are only two or three, yet the Spirit keeps us together. Please join in and share the joy we experience each Friday at 7AM. This group hopes more will join us (occasionally or regularly) in 2024.

- The St James Book Group continues to read, discuss, and share thoughts about various books throughout the year. The group grew in 2023 and has begun sharing food at meetings as the community grows.

- Thanks to Eleanor Agnew, Glenn Davidowich, and Mary Green for their work as our regular Altar Guild, along with many helpers.
- Thanks to Pat Hanson and Tony Karl for facilitating the new Connect & Engage ministry.
- Thanks to Eleanor Agnew for obtaining a \$5,000 grant to help St James become a more accessible church for all.
- Thanks to Teri Wagner for printing bulletins and other help.
- Thanks to Sherry Paszkiewicz for maintaining/distributing our prayer list and birthday/anniversary lists.

FROM THE WORSHIP COORDINATOR

"Q: Why do we praise God? A: We praise God, not to obtain anything, but because God's Being draws praise from us." ~from An Outline of the Faith, <u>Book of Common Prayer 845</u>



As a liturgical denomination, the routine of our church calendar gives most years a similar feel and flow. We add new songs, new prayers, new physical items, and new people, but there is a continuity to our worship. Scripture, liturgical forms, music, and rituals are comforting parts of our traditions that we carry forward year-to-year. Advent, Christmas, Epiphany, Lent, Holy Week, Easter, Pentecost, Ordinary Time, repeat. In the post-quarantine years, we've found ways to add more

color and used frequent displays of religious art and other meaningful items in our Sanctuary. We regularly used ikons, paintings, statues, and candles on displays near the altar or in other spots. Which have been your favorites?

We continue to find that, while many participate in our hybrid (in-person/streamed) Worship at 10AM on Sundays, we have others that watch later in the day or throughout the week. This includes regular attenders as well as visitors from around the world. Our inviting safe community for all has a more global reach than it did in February 2020, thanks to our investment in technology. We also offer Morning Prayer at 7AM every Friday, coordinated by Chris Eggert-Rosenthal, a lay-led tradition at St James for about 25 years. In Summer 2023, we tried out Evening Prayer Sundays at 10PM, an idea offered by Lisa Bruere.

In addition to our liturgical seasons and Holy Days, some special observances in 2023 included: Martin Luther King Jr/Beloved Community; Episcopal Relief & Development Sunday; Creation Care Sunday; Mental Health Awareness; Mothers & Mother Figures; Pastor Brian's ordination



anniversary; Companion Diocese Sunday; Memorial Day; LGBTQ+ Awareness; Fathers and Father Figures; World Refugee Day; A New School Year; Labor/Vocations of All; a 4-week Season of Creation series culminating with blessing of animals; Homelessness Awareness; and Veterans & Military. We've been intentional about including these themes over the years to help raise awareness of the values and priorities of our denomination/diocese/congregation, and most of them serve as good opportunities to invite a friend!

Barb Cook has been playing piano/keyboard since late 2021. I am so grateful for Barb and her willingness to share her gifts and her humor. Other weeks, I provide a variety of accompaniments using our Digital Hymnal to generate live music or occasionally use recorded music. Are you an instrumentalist or singer who'd like to share music? You can

offer a special piece for a one-time occasion, or music on an occasional/regular basis. Accompanists are welcome for a one-time occasion or to provide music on a more regular basis. Talk to me if you're interested in sharing your musical gifts in any way.

We are blessed with a dedicated and creative media team to prepare resources and operate the equipment for our livestreams. Pat Hanson and Stephen Phillips are the primary rotation of live stream operators. They control the cameras and angles, display graphics, and send it all to YouTube. We are blessed to have these volunteers, when many churches need to pay operators from outside the congregation. As part of my



Worship Coordinator position, I prepare the PowerPoints, videos, and other resources for on-screen display along with the weekly operator scripts/notes.

My staff position originally developed to support our congregation's decision to have a part-time Rector, allowing our pastor to focus on other priorities. One extra benefit of having someone in this position has been no disruptions in our Worship during our clergy transition. We were able to connect with local ELCA-ordained priest Brian Staude to be our main supply priest, and shortly after that we called him to be our 1/3-time Transition Pastor starting April 1. We also enjoyed visits from Episcopal supply priests including Father Chris Arnold, Mother Portia Corbin, Mother Bobbi Kraft, Father Jim Trainor, Pastor Mary Trainor, and a Palm Sunday visit from Bishop Matt Gunter. Twelve of our Sundays featured lay-led worship, giving us more opportunity to share the gifts of our laity.

Our Worship is made better by the service of our wonderful Readers, Crucifers, Acolytes, Thurifers, and Eucharistic Ministers. Thanks to all of you who help in those ministries. Thanks also to our Altar Guild, newly re-formed in 2023 after a long hiatus. I'm grateful to our teams and individuals who have worked to ensure our Worship services have continued smoothly throughout another unique year, and to all who have continued to participate!

CONNECT & ENGAGE MINISTRY REPORT

Our St James Episcopal Church family is the family we choose. We all want this family to thrive, evolve, and grow. The Connect & Engage ministry uses a big-picture holistic approach to help us:

- identify and connect with the people we are best equipped to reach with our resources.
- engage new people long-term in the life of our St James family once they are in our midst.

The Vestry approved the proposal to form the Connect & Engage ministry in May 2023, with Tony Karl and Pat Hanson serving as facilitators, forming ad hoc teams as needed for various tasks. In May and June, we worked with a small team of volunteers to investigate the "market" in our area to determine realistic expectations for our audience. In June 2023, the Vestry approved recommendations from the group (begin forming ministry related to

greeting/welcoming visitors; \$500 marketing expense budget for promotion and giveaways for Lakeshore Pride and following events; approve conclusions in target audience investigation report). In July, we coordinated St James participation in the first Lakeshore Pride event, where we had a chance to be present and visit with dozens of people throughout the day.

The Dine & Discuss series is a monthly opportunity to learn about and discuss topics of interest to the congregation, while enjoying a potluck meal together. In May, our Dine & Discuss series introduced the Connect & Engage ministry and each month after we began to address related topics. In June, Dine & Discuss talked about

strategies to "invest & invite" (investing in this case refers to relationships) and shared and discussed ideas for a welcoming/greeting ministry. In July, Dine & Discuss shared stories about our own experiences at St James and how we might apply that to others we can invite, and began looking at our building through the eyes of others. Each month, August through November, Dine & Discuss participants continued to look at our building through different eyes, learn about sharing our stories, discuss tips for inviting people, and share ideas about welcoming/greeting.

Based on the input from the Dine & Discuss series, Connect & Engage put together a proposal for a Welcome Team. The Vestry decided to table implementing a Welcome Team for now but asked that general information be shared with everybody. In December 2023, our Dine & Discuss focus was on welcoming. In early 2024, the Dine & Discuss themes will focus on accessibility for all. Every month we discussed upcoming events/worship themes we can promote and invite people to attend; we made the promotional materials and other resources available in the church for everybody's use.

The Connect & Engage ministry looks forward to continuing to help our congregation find ways to connect with new people and engage them long-term in our St James family.



The church boilers were cleaned, and maintenance was performed. One circulation pump was replaced as was one pressure relief valve. The system is working properly.

The elevator received its annual inspection as did the fire extinguishers. One AED and first aid kit were installed in the worship space.

Items needing attention during 2024 are the driveway approach into the parking lot, continued work on the landscaping, continued deep cleaning, and installation of a second AED in the gathering space. There are several areas downstairs that will need some light sheet rock replacement.

MISSIONS REPORT

St James continues to support Manitowoc CARElink and the Manitowoc Warming Center. CARElink is an ecumenical effort designed to efficiently help Manitowoc County residents who need assistance. By combining resources and carefully maintaining client files, financial aid can be managed. Clients can be referred to appropriate resources designed to reduce the need for future or repetitive assistance.

The Manitowoc Warming Shelter (MWS) is an ecumenical group of churches, organizations, and friends working together to provide a safe, warm, non-judgmental facility for any adult that needs overnight shelter. MWS has been housed across the street at First Presbyterian Church for 2 years with a conditional use permit, but a new location will need to be found by Fall 2024.

Asset Overview:

The checking account holds the funds available to pay bills plus \$28,031.83 which is held in Dedicated Funds.

The funds held at BankFirst in the Money Market and 7-month CD are our newly established Cash Reserves for emergencies and future improvements.

The Diocesan Common Trust (DCT) is a pooled investment with other churches of the Diocese of Fond du Lac, which minimizes costs and maintains maximum return on investment. In 2023 the market made a stellar recovery in the fourth quarter. The income earned over the entire year not only covered our quarterly withdrawals totaling \$10,000, but also the maintenance fees, resulting in an increase of \$20, 654.35 in the balance of the account. This income along with the reinvestment of \$22,345 which was a result of the 2022 Capital Campaign reinvestment pledges and a bequest specified for reinvestment in the DCT brings us to the 2023 year-end balance to \$251,124.75.

Rector's Discretionary Fund:

The Rector's Discretionary is a separate checking account, outside the operating budget of the church, which is for the use of the Rector only, in emergency aid situations as laid out in the Diocesan policy. This account is fed by parishioner donations: the first Sunday's loose plate offering in even numbered months, or any time by check with "Rector" noted on the memo line. The account is reviewed yearly by another clergy member. The balance as of 12/31/2023 is \$622.67.

Dedicated Funds:

Dedicated Funds are set aside for a specific purpose, whether designated by the donor or the vestry. The Family Fund is a large dollar extension of the Rector's Discretionary Fund. When money is used from this fund, it is replenished out of our next quarterly distribution from the DCT. At the end of each year, 10% of new unrestricted Memorial donations are given to Outreach. The ambo and lectern were purchased in memory of those who have gone before us from the Memorial and Sanctuary Décor Funds. Transient Funds are pass-thru accounts from the donor to the designated recipient.

Financial Health:

Thank you for your continued support of your parish and its ministries. However, as you are seeing happening in your own home budgets, the churches utilities and fixed costs continue to rise. Unfortunately, parishioner contributions have not kept pace with our expenses. So, just like you have planned your income for the year from wages, Social Security, Pensions, IRAs, or other investments, the church must do the same. In order for us to have a realistic projection of our income, it is very important that each household return the census/pledge, even if you are not able to make a financial commitment at the present time.
