LIHEAP is a Federal program that assists low-income individuals who cannot pay their heating bills. Eligible households can receive assistance through a direct payment to vendors who supply their fuel, or through a crisis component during weather-related emergencies, such as a broken furnace, leaking pipes, or terminated utility service. Homeowners, renters (including those whose rent includes heat), roomers and subsidized housing tenants may be eligible. Any type of fuel may be used.

The program for both cash and crisis components is usually available each heating season from approximately November to April. Besides household income, grants are based on the type of fuel used and the county of residence. To be eligible for the program, household income can not exceed 150 percent of the Federal Poverty Income Guideline, or for a one-person household, \$15,315; two persons, \$20,535; three persons, \$25,755; four persons, \$30,975; five persons, \$36,195; six persons, \$41,415. For larger households, guidelines increase by \$5,220 for each additional person.

The NACo Prescription Drug Discount Card Program allows participants to save an average of 20% off the full retail cost of medications. This program is very useful to those who are uninsured or underinsured, and can also supplement Medicare prescription and other insurance plans.

There are no age limits, income or medical condition restrictions to participate. The card is provided free for all Pike County residents; there is also no cost to taxpayers or the county. The cards may be picked up at any of the county's township or borough offices, at any branch of the Pike County Public Library, at the Area Agency on Aging Senior Center, and senior clubs.

To use the card, simply present it to any participating pharmacy. Most of the major retail chains are participating pharmacies, such as Wal-Mart, Kmart, Rite Aid, The Medicine Shoppe, among other pharmacies.

CHIP is short for the Children's Health Insurance Program - Pennsylvania's program to provide health insurance to uninsured children and teens. There are a lot of reasons kids might not have health insurance - maybe their parents lost a job, maybe their parents don't have health insurance at work or maybe it just costs too much. Whatever the reason, CHIP may be able to help.

CHIP works with private health insurance companies you know to make sure your children get their immunizations, doctor's visits, prescriptions, vision exams, check-ups at the dentist and more! For most families, all of this comes at no cost. That's right - great health insurance for free. You get the same health insurance card as everyone else, so no one needs to know you have CHIP. You might think that your children aren't eligible. Many parents are surprised to learn that CHIP can help their families.

Now, all uninsured children and teens up to age 19 have access to health insurance, regardless of family income. It's the same great program, now available to more families. It doesn't matter how much money your family makes. Many will get it free. Others, at low-cost. Don't assume that you earn too much to qualify. Every uninsured child and teen who is not eligible for Medical Assistance now has access to comprehensive health insurance. Many families will not have to pay for CHIP. Families with higher incomes will have low monthly premiums and co-pays for some services.
