1. Effective date

The new digital ExtraCare Health Card is effective February 2020.

2. ExtraCare Health Card overview

The ExtraCare Health Card is an exclusive card from Aetna and CVS Pharmacy[®]. The ExtraCare Health Card provides savings of 20 percent on thousands of CVS Health Brand[®] health-related items.

This program is primarily offered to employees (cardholders) through an email outreach once new employees are added to the plan.

Employees can easily activate their benefit through the email they'll receive, or they can use the link: **bit.ly/extracarehealth**.

Please note: Employees must wait until they receive the email invite to enroll, and/or at least 60 days after the plan's effective date. If plan members try to activate through the website link too early, the benefit with the added 20 percent discount will likely not be active.

We encourage the supplemental promotion of the program. Not every employee may have an email address or have granted the required permissions to receive emails (which allows Aetna Pharmacy to offer program enrollment).

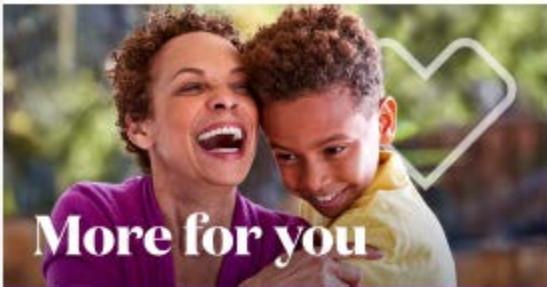
Employees must be enrolled and an authenticated member, and the client active for the program before the program is offered through alternate channels.

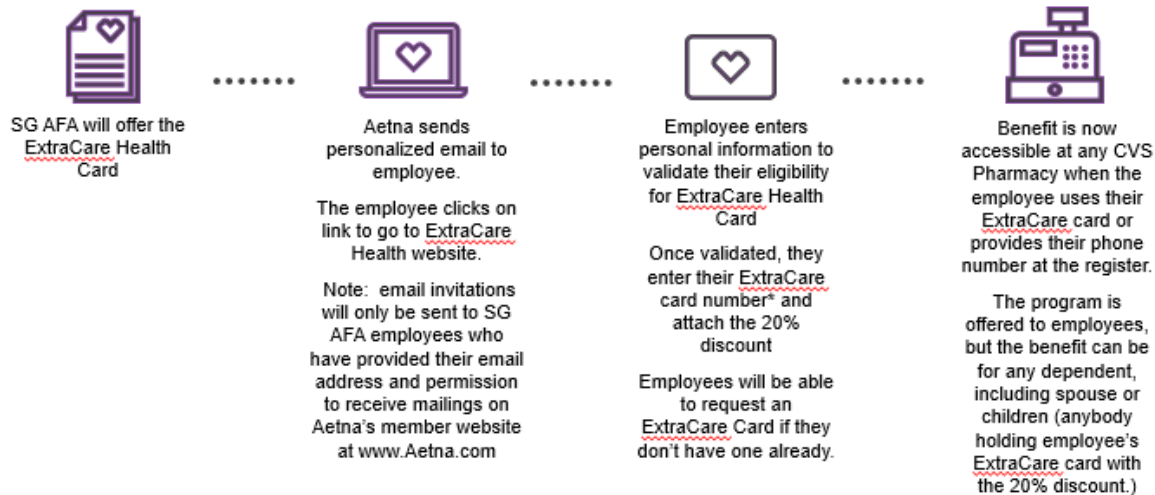
