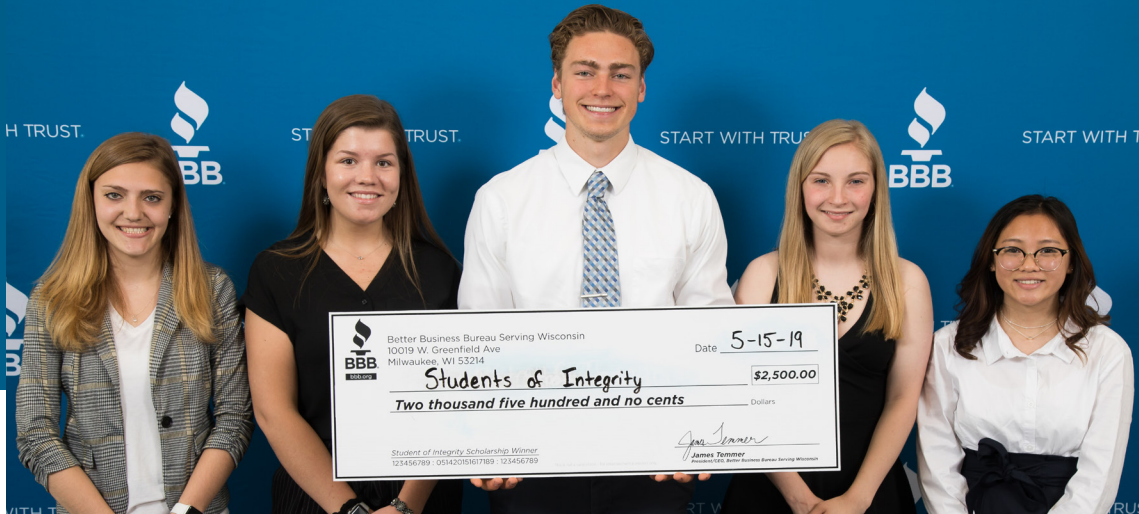

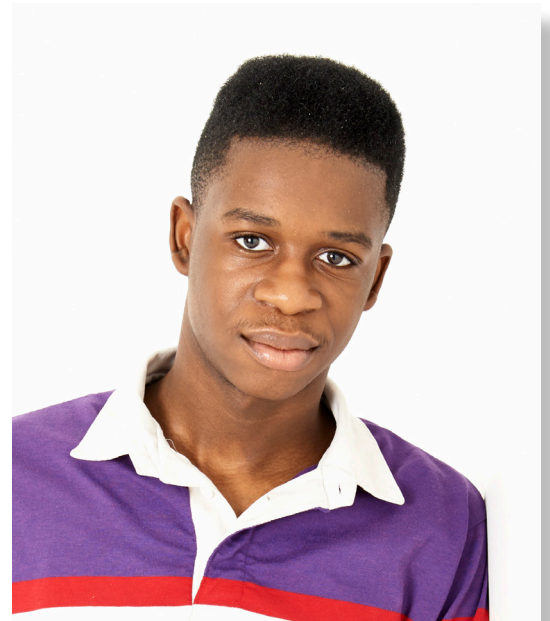


ABOUT THE SCHOLARSHIPS

From eligibility requirements to deadlines, here's the basic information you need to know to apply for a scholarship!

Better Business Bureau® Serving Wisconsin awards scholarships to Wisconsin high school students who have demonstrated character, leadership and ethical values. The scholarships will be awarded for post-high school education at any Wisconsin-based accredited college beginning in the fall of 2022 including community colleges and technical colleges. As the scholarship recipients pursue their careers, BBB Serving Wisconsin hopes to develop future business leaders who will promote ethics in the Wisconsin marketplace.

ABOUT THE SCHOLARSHIPS

Scholarship Amount

In 2022, there are a total of 15 scholarships, each in the amount of \$2,500.

Eligibility

To be eligible for this award, the student must:

- Be a high school senior
- Be a Wisconsin state resident
- Have a 3.0 GPA or show consistent GPA improvement over time
- Plan to attend a Wisconsin-based accredited Higher Education Institution (two or four year)

Judging Criteria

Entries will be reviewed by a panel of judges comprised of Wisconsin business leaders and members of the academic community, and scored based on five elements: essay (50%), letters of reference (20%), community involvement/employment (10%), academics (15%) and first generation students (5%).

Application Deadline

Applications are due on
March 15, 2022 by 4:00 p.m.

All Letters of Reference must be submitted and received by this time.

APPLICATION CONTENTS

Here's a section-by-section breakdown of the scholarship application to help you put your best foot forward.

Section 1: Applicant Information

- Provide basic applicant information including the name of your high school, as well as contact information for your school counselor and parent/guardian.

Section 2: Community Involvement/Employment

- List any volunteer or community engagement activities you have participated in, whether at school or within your community.
- List any awards/honors you've received, or offices held and length of participation.
- Provide basic information about any employment/work experience you've had during high school.

Section 3: Letters of Reference

- Provide contact information for two (2) letters of reference. You'll want to select two individuals who aren't related to you and can speak about your integrity and character.
- Your letters of reference will be submitted separately from your application. You will only need to provide the contact information. We will send an email to your references with instructions on how to submit their recommendations.
- Reach out early to make sure your references have sufficient time to meet the **March 15, 2022** deadline.
- You will receive a confirmation email when each letter of reference has been received and completed.

Section 4: Academic

- Upload your school transcripts.
- Provide your SAT or ACT scores with an official test score copy.

Section 5: Essay

- Students have the option to submit a personal essay in either written, video, or audio format. The essay must be less than 500 words, or less than two minutes for audio/video submissions. Anything over 500 words or two minutes will not be considered.
- All submissions are scored using the same criteria. There is no advantage to submitting your essay in one format over the other.
- The following essay prompt should be answered in the essay, video, or audio entry:
 - Describe a unique situation where your moral convictions and personal ethics were challenged, and you made the difficult decision because it was the right thing to do, despite the possible consequences. In your response, be sure to address the following questions:
 1. How did you come to this decision and what was the outcome?
 2. What did this situation teach you?
 3. What or who has influenced the development of your integrity?

Section 6: Post Secondary Plans

- Provide the name of the college you plan to attend and your intended major.
- Describe what you plan to achieve with your college education.

Click “submit” and you’re done - it’s that easy!

If all sections aren’t included we won’t be able to consider your application for eligibility.

FREQUENTLY ASKED QUESTIONS

The Scholarship

How many scholarships are available?

Each year, BBB Serving Wisconsin awards students with a \$2,500 scholarship each.

I don't have the best grades/I didn't score very well on my ACT/SAT, should I still apply?

Of course! Keep in mind that our scholarship awards students for their integrity. Top grades and test scores do not automatically mean a student has integrity. And having average grades does not mean that a student lacks integrity.

My school offers few or no AP classes, will this affect my application?

Don't worry, this will not have any affect on your application. We recognize that not all schools have the same resources or are able to offer all of the same classes.

I am planning on going to a community college/technical school. Am I still eligible?

Yes, and we highly encourage you to apply! BBB Serving Wisconsin recognizes that community colleges and technical schools offer valuable career opportunities that are important to the many industries of our state. Two of the 10 scholarships are designated for students attending two-year colleges or tech schools.

The Application

Do I have to submit my application online?

When is the application due?

The student application and all letters of reference need to be submitted by **March 15, 2022 at 4:00 p.m.** We encourage you to submit your application early so that the individuals writing your letters of reference are notified with enough time to submit their letters before the deadline.

Why do I have to provide my congressional district?

Because we serve our entire state, BBB Serving Wisconsin wants to make sure our outreach covers all of Wisconsin based on population density. We use the congressional districts as an easy guideline to identify which regions the students represent.

How will my application be scored?

Essay (50%)
Letters of Reference (20%)
Community Involvement/Employment (10%)
Academic (15%)
First Generation (5%)

What do I have to discuss in my essay/video/audio submission?

You will be asked to answer the following essay prompt and questions:

- Describe a unique situation where your moral convictions and personal ethics were challenged, and you made the difficult decision because it was the right thing to do, despite the possible consequences. In your response, be sure to address the following questions:
 - How did you come to this decision and what was the outcome?
 - What did this situation teach you?
 - What or who has had an influence on the development of your integrity?

How is the essay scored?

Your submission will be scored based on the following criteria:

The student's understanding of integrity (10pts)
The structure of the essay (10pts)
The relevance of the essay (10pts)
The essay correctly answers the questions (10pts)
The originality of the essay (10pts)

Does it matter which format I use to submit my personal essay?

No, the personal essay submissions will be judged equally and you will not be penalized for choosing one format over the other. We wanted to give students more options on how to tell their personal story and so you should pick whatever format you feel will represent your story the best.

CHARACTER ETHICS

What do we mean when we talk about integrity and character ethics? Here's our take on the principles that help develop leadership and character.

Integrity focuses on ethical character traits, not on compliance to a set of rules. The goal of our Students of Integrity Scholarships program is to help Wisconsin students develop leadership and character so that, one day, they'll become business leaders who pave the way for a more ethical, trusting and productive future for our state.

BE PRINCIPLED AND GENUINE

1. Seeking Wisdom

Seek something greater than intelligence or knowledge; seek wisdom, knowing what's right and true. (Traits: principled, prudent, contemplative and humble)

2. Trustworthiness

Be counted on to stay true to my beliefs. (Traits: genuine, reflective, self-aware and dedicated)

3. Integrity

Do what I say I will do. (Traits: reliable, consistent, predictable and orderly)

4. Honesty

Tell the truth, but with compassion for the feelings of others. (Traits: discrete, discerning)

CHARACTER ETHICS

VALUE OTHERS

5. Respect

Treat others as I would want to be treated. (Traits: inclusive, engaging and honoring)

6. Compassion for Others

Be kind to others, even if it's not deserved. (Traits: kind, gentle, patient, encouraging, benevolent and generous)

7. Forgiveness

Be willing to forgive others, even when undeserved, and ask humbly for others to forgive me. (Traits: patient, grateful and merciful)

8. Unity

Build relationships that foster harmony and collaboration. (Traits: reconciler, integrator and collaborator)

9. Learning & Mentoring

Grow in wisdom and pass it on. (Traits: curious, creative, teachable, inspirational)

10. Serving & Leadership

Put the success of others and the group above myself. (Traits: selfless, optimistic, future-oriented, visionary)

11. Honoring Authority

Respect legitimate boundaries for behavior. (Traits: dutiful, law-abiding, civil)

SEEK RESULTS

12. Justice

Uphold truth, expose error and correct wrongs. (Traits: impartial, unbiased, diligent, decisive)

13. Courage

Consistently and persistently act on my strong convictions. (Traits: tenacious, determined, unwavering, strategic, resilient, grit)

14. Accountability

Scrutinize myself and welcome the scrutiny of others. (Traits: open, up-front, self-disclosing, transparent)

15. Stewardship

Live as if I will eventually reap what I sow. (Traits: careful, ordered, generous, astute, watchful)

16. Seeking Council

Seek advice from others who have astute wisdom, particularly when confronted with ethically ambiguous issues. (Traits: thoughtful, curious, discerning)

17. Responsibility

Fulfill my personal responsibilities as a good citizen. (Traits: self-governing, self-controlled, self-disciplined)

18. Excellence

To be and do my best work every day. (Traits: enthusiasm, focus, determination, consistency)

DISPLAY GROWTH

19. Maturation

Learn from experience and seek personal improvement over time. (Traits: positive change, healthy growth, wise choices)

20. Transformation

Exhibit consistent, positive and intentional commitment to higher character. (Traits: high character, ethical conscientious, healthy growth, wise choices)
