Following the tragic death earlier this fall of my son when he was struck by a motorist while using the crosswalk in front of his junior high on his way to school, I learned it is not a felony in Wyoming if a motorist hits and kills a pedestrian, even if using a crosswalk. I have learned surrounding states have stricter penalties in place and such enhanced penalties can be a tool, not only in seeking justice for victims' families, but also in serving as a deterrent for distracted driving and other dangers behind the wheel. My tragic loss is, unfortunately, a far too frequent occurrence across Wyoming. It is timely to build upon the good work done concerning motorists who fail to stop for the flashing lights and stop signs of school buses and look more broadly at pedestrian safety, the effectiveness and allocation of resources and infrastructure throughout our communities and identify solutions to achieve safer pathways for our citizens.
