Ending the HIV Epidemic: A Plan for America

An [initiative to end the HIV epidemic](#) was announced during the recent State of the Union Address and described by HHS Secretary Alex Azar as “a once-in-a-generation opportunity to end the epidemic, thanks to the most powerful HIV prevention and treatment tools in history and new tools that allow us to pinpoint where HIV infections are spreading most rapidly.”

The [Ending the HIV Epidemic: A Plan for America](#) aims to reduce new infections by 75 percent in the next ten years, averting more than 250,000 HIV infections in that span. It includes three major areas of action:

- Increasing investments in geographic hotspots through existing, effective programs, such as the [Ryan White HIV/AIDS Program](#).
- Using data to identify where HIV is spreading most rapidly and guide decision-making to address prevention, care, and treatment needs at the local level.
- Creating a local HIV HealthForce in these targeted areas to expand HIV prevention and treatment.

There are several factors contributing to this unprecedented opportunity:

- [HIV medicine antiretroviral therapy \(ART\)](#) when taken as prescribed makes it possible for persons with HIV to live long, healthy lives and have effectively no risk of sexually transmitting HIV to a partner.
- [Pre-exposure prophylaxis \(PrEP\)](#) medications have reduced the risk of contracting HIV from someone by up to 97 percent.
- New laboratory and epidemiological techniques create the opportunity to focus on geographic regions in greatest need of additional resources.

Strengthening Systems of Care for People Living with HIV and Opioid Use Disorder
