



Missouri Right to Life, National Right to Life, and pro-life people across the country are united against Planned Parenthood and the evils of abortion

While some try to create contention and controversy among pro-lifers, Missouri Right to Life, National Right to Life, and other pro-life organizations will stay focused on the battle to protect women and save babies.

The following are a few real battles we are fighting:

First is the atrocity of the St. Louis Planned Parenthood continuing to break Missouri laws and operate without a license. The Missouri Department of Health has uncovered their substandard medical care which has resulted in multiple emergency ambulance calls where women were rushed to a hospital. Pray for our Attorney General and his staff of lawyers as they work to present the truths to the courts.

Second, the opponents of HB 126 are delaying enforcement of this critical bill that will ban abortion when there is a heartbeat or when the baby can feel excruciating pain during an abortion. They have also challenged a ban on abortion of babies based on race, sex, or a Down Syndrome diagnosis. The Court is clearly biased for the pro-abortion agenda and denies all medical facts. Pray for our Attorney General and his staff of lawyers as they work to present the truths about babies' heartbeats, pain capability, and the value of life of special needs babies.

In Washington D.C., the pro-abortion Democrats continued their attack on President Trump and our pro-life laws.

First, the sham investigation of President Trump has come to the full committee of the House under pro-abortion Congresswoman Nancy Pelosi. Make no mistake, this attack on President Trump is based solely on trying to undermine his campaign for the 2020 election. President Trump has worked on many levels to put in place pro-life protections for women and babies. He has defunded Planned Parenthood from receiving our federal tax dollars. In addition, he has appointed many pro-life judges on the federal courts and two U.S. Supreme Court Justices who will adhere to the original intent of the U.S. Constitution. Pray for President Trump, his family, and his attorneys as they fight to stand for America against the pro-abortion leadership of the U.S. House of Representatives.

Second, under the leadership of pro-abortion Pelosi, the U.S. Congress passed out of committee H.J. Res. 79, a measure that purports to erase the seven-year ratification deadline that Congress included in the Equal Rights Amendment (ERA) resolution submitted in 1972. NARAL Pro-Choice America and National Right to Life both say that the ERA would likely be employed to invalidate laws that are protecting unborn children. Pray for our pro-life Congressmen and women as they stand against the pro-abortion leadership of the U.S. House of Representatives.

Missouri Right to Life will continue our work with pro-life leaders as we stay focused on the battles at hand. This is a historic time in Missouri. Abortion numbers are dropping and one lone abortion clinic is teetering. We are doing a great work together, and we will not be distracted by deceptive reporting.

President Donald Trump's wonderful pro-life record on appointing judges

For many years, National Right to Life and its state affiliates have labored intensively and diligently to elect pro-life candidates, who then enacted pro-life laws – only to see Planned Parenthood, the Center for Reproductive Rights, or a local abortion facility challenge those laws in court. Far too often, the challenges were successful because some judges legislate from the bench rather than follow the U.S. Constitution.

During the 2016 presidential campaign, with a vacancy on the U.S. Supreme Court due to the death of Justice Antonin Scalia, Trump released a statement acknowledging Scalia's legacy, adding, "His career was defined by his reverence for the Constitution and his legacy of protecting American's most cherished freedoms. He was a Justice who did not believe in legislating from the bench, and he is a person whom I held in the highest regard and will always greatly respect his intelligence and conviction to uphold the Constitution of our country."

The presidential candidate also made public a list of persons from which he said he would pick nominees for vacancies on the Supreme Court, saying those on the list were "representative of the kind of constitutional principles I value."

On November 6, 2019, NRLC Executive Director David N. O'Steen, Ph.D, NRLC Federal Legislative Director Jennifer Popik, J.D., and NRLC President Carol Tobias had the wonderful opportunity to attend an event at the White House at which President Trump showcased the achievements of his administration in federal judicial nominations.

The President told those in attendance that, working with the Republican-controlled U.S. Senate, he now has 158 judicial nominees confirmed to the federal bench, including two Supreme Court justices, 44 circuit court judges, and 112 district court judges.

President Trump has appointed more

circuit judges at this point in his presidency than any president in recent history. Fully 25% of all active judges on courts of appeals have been appointed by President Trump.

The President delighted the appreciative audience by saying he is on track to have more judges confirmed this year than in his first two years combined.

The nomination and confirmation of so many judges who respect and carefully adhere to the text of the Constitution bodes well for the lives of unborn children.

Pro-life group helps young mom finish college, educates students on 'pregnant and parenting' rights

A national pro-life group launched a campaign to inform college students who are pregnant or are already parents of their rights on campus -- and they got to inform one mom about how they're going to help her finish school.

Students for Life of America (SFLA) helped Ruth Asmarzadeh, a college student who was unable to finish her degree at Pikes Peak Community College in Colorado after she says her Title IX rights were violated. She became pregnant in 2016 and said she was pressured to get an abortion. Ultimately, Asmarzadeh chose to have her child.

"I don't like to imagine my life without my son or my education," she told Fox News. "In fact, it breaks my heart knowing at one point I had to choose between the two."

Ruth and her son, Eli, received a scholarship from Students for Life of America to help her finish school as part of the pro-life group's "Pregnant on Campus Initiative."

She said she felt "helpless" when she lost her financial aid and wasn't able to reschedule her exams, so she reached out to the pro-life organization, which helped her get financial aid back -- and threw her a baby shower. This week, SFLA surprised her with \$6,000 to ensure she could finish her education.

SFLA president Kristan Hawkins called Asmarzadeh, who is currently working three jobs, to let her know about the surprise after the group launched

a national campaign, the "Pregnant on Campus Initiative," to help pregnant and parenting students get the resources they need on campus.

"One of the things we always say at Students for Life is no woman should have to choose between her education and her child," Hawkins told Asmarzadeh. She also informed Asmarzadeh about the fundraising page reaching the amount she needed to get her degree and "the job of her dreams."

"Thank you. I'm honored and grateful for all of this," Asmarzadeh said, as her son, Eli, could be heard talking in the background. "I'm sure he will be very thankful when he's able to understand one day. Thank you."

SFLA also informed Asmarzadeh's college that her Title IX rights were violated as part of the campaign to let other students know they cannot be discriminated against or face the loss of scholarships, housing, athletic eligibility, or an opportunity simply because of their pregnancy or parental status.

As part of the "Pregnant and Parenting Bill of Rights," Hawkins said the first step is to educate students about their rights on campus, especially given the pressure of abortion in higher education today. Then the intention is to provide them with support, including legal assistance from Alliance Defending Freedom.

"Pregnancy should mark the beginning of a new life, not the end of an academic career," Hawkins said in a statement. "Know your Title IX rights."

Asmarzadeh says she feels empowered by SFLA's help and hopes to one day give back as a licensed counselor. She plans to return to school during the spring semester.

There have been nearly **61 million abortions** in the U.S. since 1973.


There were over **800,000 abortions** in 2017. That is nearly **2,400 abortions per day, 98 per hour, 1 every 34 seconds.**

Planned Parenthood opens new mega killing center in Fairview Heights, Illinois



Just days before Planned Parenthood's latest killing center was expected to open, Missouri State Senator Bob Onder and Pam Fichter, MRL-Eastern Region Chairman and past State President, speak at the Expose Planned Parenthood Rally.

A Planned Parenthood clinic that was built in secret has sparked protests from pro-life demonstrators who call the clandestine construction "an embarrassment" and a "sign of desperation."

Fox News reported that Planned Parenthood said it kept the construction secret over fears that contractors and utility providers might pull their services. Other abortion sites have encountered problems during construction when the public realized it would be an abortion business.

Hundreds of pro-life activists gathered outside the building -- outside the iron fence -- on October 9 for the Expose Planned Parenthood Rally as preparations were being finalized to open the

newest site to commit abortions.

Pro-life leaders from both sides of the Illinois/Missouri state line took part in the rally.

"This facility behind us is not a victory for Planned Parenthood, it is a sign of desperation," Mary Kate Knorr, the Executive Director of Illinois Right to Life, told the *Belleville News-Democrat*.

Kathleen Wilson, a frequent pro-life demonstrator who lives in the area, told the *News-Democrat* that the clinic "is an embarrassment for our community, for our state."

January is Girl Scout cookie season in most of our state.

You might think that by ordering some thin mints or trefoils, you are supporting young women in healthy pursuits. But think it over before purchasing those munchies.

A few things to consider:

- Girl Scouts USA (GSUSA) and local councils encouraged and celebrated girl members' participation in the 2017 and 2018 pro-abortion Women's March.
- Girl Scouts' G.I.R.L. 2017 mega event, “the largest global gathering of girls and influencers,” featured prominent abortion rights supporters Chelsea Clinton and Barbara Pierce Bush.
- Girl Scouts' curriculum for girls, sold and promoted by every local Girl Scout council, recommends pro-abortion role models/organizations such as Betty Friedan, Gloria Steinem, Geraldine Ferraro, Hillary Clinton, Amnesty Intl., Population Council, ACLU, and National Organization For Women.



- GSUSA and local Girl Scout councils' on-line content honors and promotes pro-abortion politicians (Hillary Clinton), activists (Margaret Sanger), celebrities (Emma Watson), and media sites (Teen Vogue).

- GSUSA confirms that its local councils and troops may collaborate with Planned Parenthood.

Because of significant, well-researched information about Girl Scouts USA activities and affiliations, Missouri Right to Life issued a policy statement in 2013 and later updated it:

Because Girl Scouts USA promotes, both directly and indirectly through other organizations, policies and behaviors clearly contradictory to the goals and purposes of Missouri Right to Life, Missouri Right to Life urges citizens to consider carefully whether to participate in Girl Scouts or support them in any way.

The Pro-Life Christmas Story: We Are Stronger Than Our Circumstances

Imagine. Waking up to find that your wife is pregnant...and you had nothing to do with it. And then, an angel appeared to you telling you that she carried the Hope of humanity within her and you were to name him “Jesus”. This could never have been part of any foreseeable plan for a newly married man. How would he cope with a pregnant wife and a marriage that had not yet been consummated? In a culture of undeniable (and real) gender inequality, where women were horribly stoned for adultery, he could have divorced her and publicly shamed her.

Joseph could have chosen disgrace, but he chose grace instead. He decided to be stronger than his circumstances.

Imagine. You’re a young virgin bride who has yet to intimately know your husband, and you’re told by an angel that you have been chosen to carry the Savior of the world within your womb. She didn’t plan this. But her consent triggered events that would radically change her life, her husband’s life, and ... the world. How would she explain this miraculous conception to her husband? How could she even accept that something like this was even possible?

She could have chosen to reject it all. She could have justified it because the timing wasn’t “ideal” or felt that their material poverty was sufficient reason not to bring a child into this world. But she decided to be stronger than her circumstances.

Mary and Joseph lived in a violent culture under Roman rule (where infanticide was a common practice) and a ruthless appointed “King of the Jews”—King Herod—who was furious at

the prospect of a child becoming the King of the Kings. Herod was a deeply unstable man who had his own family members (including his wife and firstborn son) and many others killed. He was so threatened by what the life of this humanly unplanned but Divinely planned child represented, that he ordered all male children (two years of age and younger) in Bethlehem and the surrounding areas to be slaughtered. With God’s divine intervention, Mary and Joseph escaped the brutality of a foolish King hell-bent on destroying the Son of God.

A devoted husband and his courageous wife had to trust each other and trust the Lord that He would guide them through this earthly uncharted journey. Their lives had purpose. Their unborn son’s life had purpose. Mary saw motherhood as a gift, not a burden. She embraced it despite all of the unknowns. And Joseph could have chosen abandonment over fatherhood, but he chose adoption instead. What an illustration of how fathers matter even when the bond isn’t biological.

Courage unleashes miracles. This Christmas, may we be reminded of the faith and vulnerability that is required in our own journeys. May we never forget that Christmas is the beginning of God’s love story for us and completed in the ultimate act of selfless love — Christ’s self-sacrifice on the cross and miraculous resurrection. May we know, in a deeply personal way, how much God loves us enough to offer eternal salvation and the opportunity to be strong, through Him, even in our weaknesses.
