Success Stories: Examples of Property Donated

Mid America Flight Museum (Mt. Pleasant, TX)

- Aircraft tractor (“tug”)
 - Donated in May 2015
 - TFC Service Charge = \$4,500
 - Orig. Acquisition Cost = \$21,690
- Humvees
 - Donated in May 2017
 - TFC Service Charge = \$5,000/ea.
 - Orig. Acquisition Cost = \$41,000+/ea.



Success Stories: Examples of Property Donated

- The National Vietnam War Museum, Mineral Wells, TX
 - Opened a new Visitor Center in May 2011 using a double-wide mobile home obtained through FSP
 - Previously used at President George W. Bush's ranch in Crawford, TX to house the White House staff.
 - It had been outfitted with numerous electrical outlets, and bedrooms had been converted to communications room. Even after the permanent Visitor Center is built and the building finds another use, the museum plans on keeping it as a historic artifact

 - NASA space shuttle training aircraft
 - Once flown by Amarillo native Rick Husband who was one of the seven astronauts that died February 1, 2003 in the Space Shuttle Columbia


