## Speaker Biographies

### Anne Paruti, Assistant United States Attorney

*United States Attorney's Office-District of MA*

Anne Paruti currently serves as the Deputy Chief of the Major Crimes Unit, where she helps oversee the work of AUSAs prosecuting a variety of federal crimes. She is also the district's Project Safe Childhood coordinator; in that role, she oversees child exploitation cases prosecuted throughout the district, is involved in collaboration with local District Attorney's Offices, and helps to develop and implement the district's PSC outreach program. Anne has been a prosecutor since 2007, first at the Middlesex District Attorney's Office, and then as a federal prosecutor at the U.S. Attorney's Office. She has focused her practice on child protection since 2012.

### Eileen Moriarty, Assistant District Attorney

*Cape & Islands District Attorney's Office*

Eileen Connors Moriarty started her career at the Cape and Island's District Attorney's office as an intern in 2003. In 2005 she became a full time Assistant District Attorney. Over the years Assistant District Attorney Moriarty has prosecuted cases in all of the Cape and Islands District Courts. She has been the Juvenile Court Prosecutor since 2010.

### Special Agent Lisa Crandall

*Federal Bureau of Investigation – Boston Field Division*

Lisa is a Special Agent with the Federal Bureau of Investigation. Lisa is assigned to the Boston Division and works out of the Lakeville Resident Agency. Lisa has a Bachelor's of Science in Business Administration with an emphasis in Finance and has also received an MBA. Lisa has been employed with the FBI since June 2010 and has worked cases involving child exploitation for approximately seven years.

### Detective Sergeant Andrew McLaughlin

*Orleans Police Department*

Andy holds a bachelor's degree in criminal justice and has been a police officer for 20 years. He is currently a detective sergeant with the Orleans Police Department and he routinely investigates cases involving child exploitation, sexual assaults, sudden deaths, narcotic, and cybercrimes. Andy is actively involved with school safety on Cape Cod and he has been educating the staff and students in the Nauset School District about internet safety and active threats. He feels strongly that open discussions with children can help protect them and minimize their likelihood of being a victim.

### Lauryn Myers, Victim Witness Specialist

*United States Attorney's Office-District of MA*

Lauryn is the Victim/Witness Specialist within the United States Attorney's Office who handles all crimes involving child exploitation throughout the Commonwealth of Massachusetts. With a degree in psychology with an emphasis in forensics and her experiences within the field since 2015, she has helped hundreds of victims through criminal prosecutions in state and federal jurisdictions. Lauryn is an active team member of Project Safe Childhood in hopes to promote safety for all children.
