GENERAL STATEMENT OF RESPONSIBILITIES:

Provide instruction for Paramedic program during the 2020/2021 Academic Year.

EXAMPLES OF DUTIES:

1. Assist with the development of the course syllabus.
2. Develop lesson plans and deliver class lectures.
3. Develop and distribute class handouts/lecture notes.
4. Administer, score, and record written exams.
5. Administer, coordinate, grade, and record practical exams.
6. Provide assessments of the students' progress in achieving acceptable program requirements, per MCCC/DCE contract.
7. Perform additional administrative functions associated within the Paramedic training program.
8. Record attendance and facilitate makeup sessions.
9. Coordinate lab sessions with Assistant Instructors.
10. Assist with Platinum Planner and EMS Testing as needed.

MINIMUM QUALIFICATIONS:

1. Associate degree or higher in a related field.
2. Current Massachusetts Paramedic certification.
3. Current certifications in and Instructor credentials for AHA courses: BLS, ACLS, and PALS.
4. Current NREMT or NREMT/Commonwealth of Massachusetts Paramedic certification at or above the level of assigned course.
5. Adequate training and experience in delivery of pre-hospital emergency care at appropriate level including proper care and transport of patients, medical direction, and quality improvement in pre-hospital care.
6. Thorough knowledge of National EMS Education Standards and the ability to teach all scheduled curriculum set forth by the National EMS Standards accurately and in a positive manner.
7. Ability to effectively provide instruction on assigned subject(s) as a result of academic preparation, training and experience, and perform all skills associated with course subject matters correctly, efficiently, and with proficiency.

8. Current working knowledge of and experience with Massachusetts Statewide Treatment Protocols, Massachusetts EMS system and NREMT procedures, including application of National EMS Standards.
9. Knowledge of or willingness to participate in training for Platinum Planner and EMS Testing Programs.

ADDITIONAL PREFERRED QUALIFICATIONS:

1. Two years of experience as a Paramedic functioning on an emergency response ambulance.
2. Current Massachusetts EMS Instructor/Coordinator or other accepted EMS education credential.
3. Professional development in teaching at the community college level.
4. Experience using evidence-based strategies to support student success including frequent communication and active learning.
5. Teaching experience using learning systems to support and improve instruction.
6. Previous Paramedic Lead Instructor experience.
