**September 16, 2021 (Barnstable, MA)** - The Barnstable County Human Rights Advisory Commission (BCHRAC) seeks candidates to fill vacancies beginning January 1, 2022. The (9) member volunteer Advisory Commission promotes equality and human rights throughout the County.

Responsibilities of the Advisory Commission members include attending monthly BCHRAC meetings, participating in at least one board committee, and assisting the Human Rights Coordinator in educating the public about the BCHRAC through community and educational activities.
