

## **Westmoor PTO Executive Board Positions**

### **Open for the 2021-2022 School Year**

The PTO Nominating Committee will be assembling a slate of nominees for the 2021-2022 PTO Executive Board. The positions that will be open are: Vice President (2 years- 1<sup>st</sup> year as VP, 2<sup>nd</sup> year as President), VP Fundraising (2 years), VP of Programs (2 years), VP of Social (2 years) and VP Recording Secretary (2 years).

If your student only has one year left at Westmoor or you are only able to commit to one year, we'd love to consider you for a one-year term if you'd like to serve!

The duties and responsibilities of these positions are as follows:

#### **President-**

- Communication with Principal
- Westmoor Weekly Communication submission
- PTO Council Liaison, attending monthly PTO Council meetings
- Establish Agendas and run monthly WM PTO meetings
- Legislation/Bylaws
- Paperless PTO management, in coordination with Vice President
- PTO Closet Organization / Usage
- Oversees all Executive Board positions

Committees that report to the President are primarily District committees and include:

- 1) Gift Card Plus
- 2) HOH
- 3) Block Parent / Sister School
- 4) District 28 Parents Night Out "Cheers to 28" (every other year, due in 2021-2022)

#### **Vice President-**

- Acts as assistant to the President.
- Primary manager of Paperless PTO
- Oversees the volunteering at Westmoor by creating, or overseeing the creation of, committees and roles on PPTO and the use of Sign Up Genius ("SUG") as needed.
- Establishes protocols for communication among the volunteers/Executive Board/Westmoor families.
- Facilitates end of year wrap up reporting, manages PPTO and sign up forms for the school for the following year, etc.
- Responsible for publicity for PTO including updating Facebook page, email blasts in conjunction with President

**VP Fundraising** – Oversees all annual strategic planning for fundraising efforts for the PTO.

Organizes and manages the annual fundraising schedule/timeline, and guides fundraising committee chairs to execute successful fundraisers.

Committees that report to VP Fundraising:

- 3) Birthday Signs
- 4) Book Fair
- 5) Box Tops
- 6) Free Will
- 7) Misc. Fundraisers including Dine'n Share/Rockin' Jump/Waterway Car Wash

- 10) Special Lunch
- 11) Spirit Wear

**VP of Programs** – Organizes PTO-sponsored educational field trips and assemblies for the student body. Committees that report to the VP of Programs:

- 1) Family Math
- 2) Science Fair
- 3) Birthday Books
- 4) Artist in Residence (every other year)

**VP Social** – Organizes special grade-level or school-wide social events and sets social calendar school-wide. Coordinates grade-level social committee to design and run a grade-level social event for families and/or Parents-only. Coordinates community involvement activities that the PTO sponsors and runs for the school community.

Committees that report to VP of Social:

- 1) Bulldog Bash (fall Family Event)
- 2) Grade Level Fun Nights
- 3) Family Picnic
- 4) Family Nights (i.e. Movie Night/Bingo Night)
- 5) Community Connections Events

**Recording Secretary** – Records minutes at the monthly PTO meetings and distributes them to the rest of the Westmoor families, and communicates with the school secretary for promoting the meeting as well as the custodian to hang the PTO Banner. Designs and updates the PTO bulletin boards in the lobby at Westmoor periodically throughout the year.

**General PTO Executive Committee member responsibilities:**

- Provide end of year report/timeline on activities and budget used
- Attend monthly meetings and provide update for your area (7 meetings a year)

Installation of new Board members occurs at the final PTO meeting of the school year in May.
