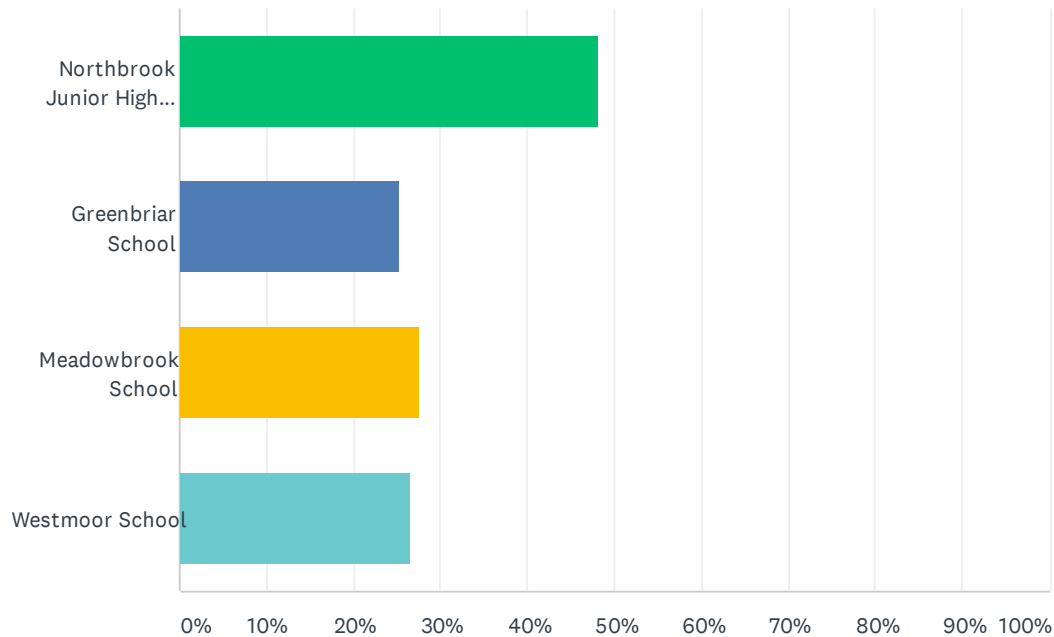


# Q1 Please identify the school(s) where your children will attend in the 2020-21 school year (check all that apply).

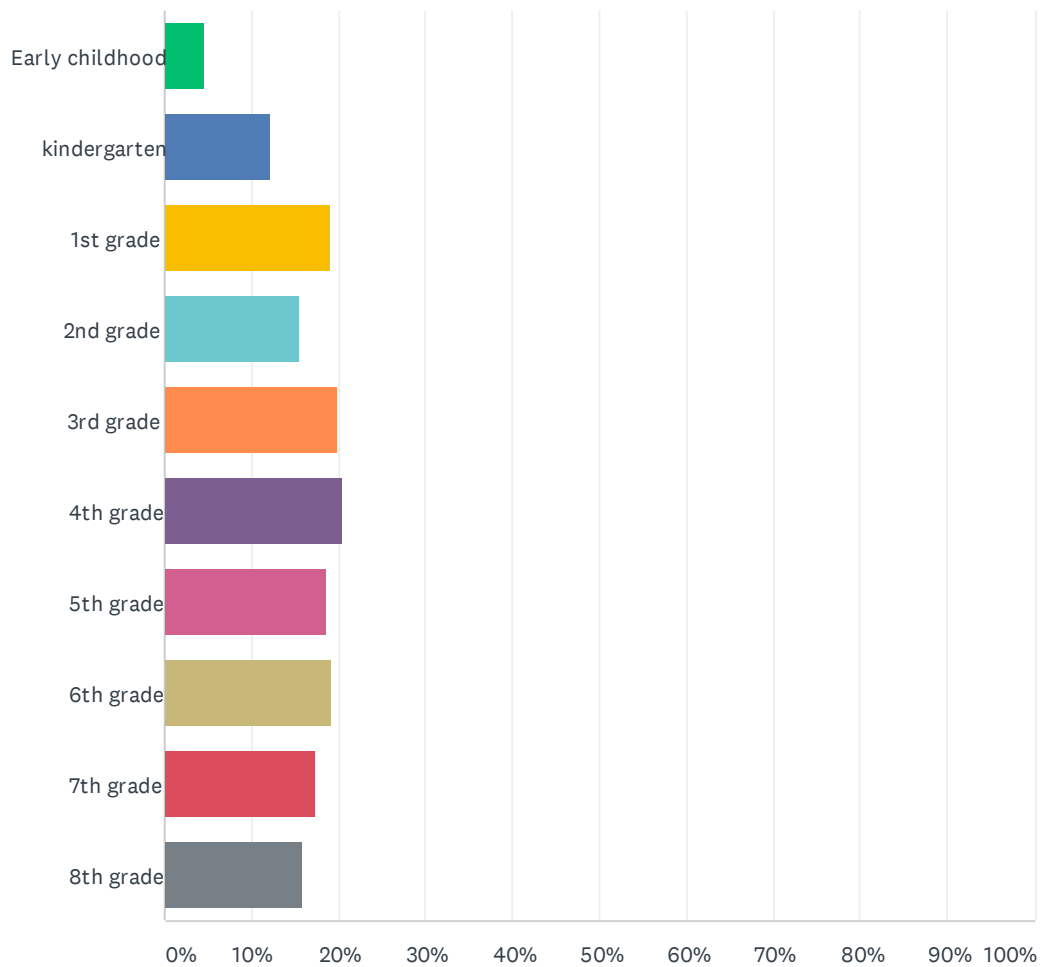

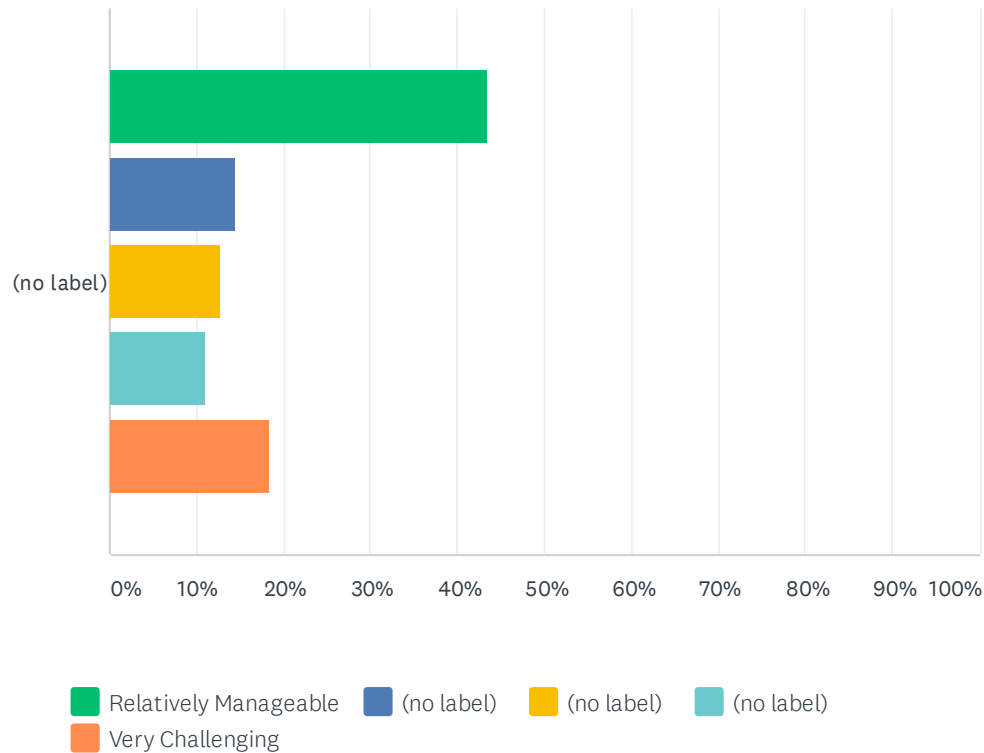

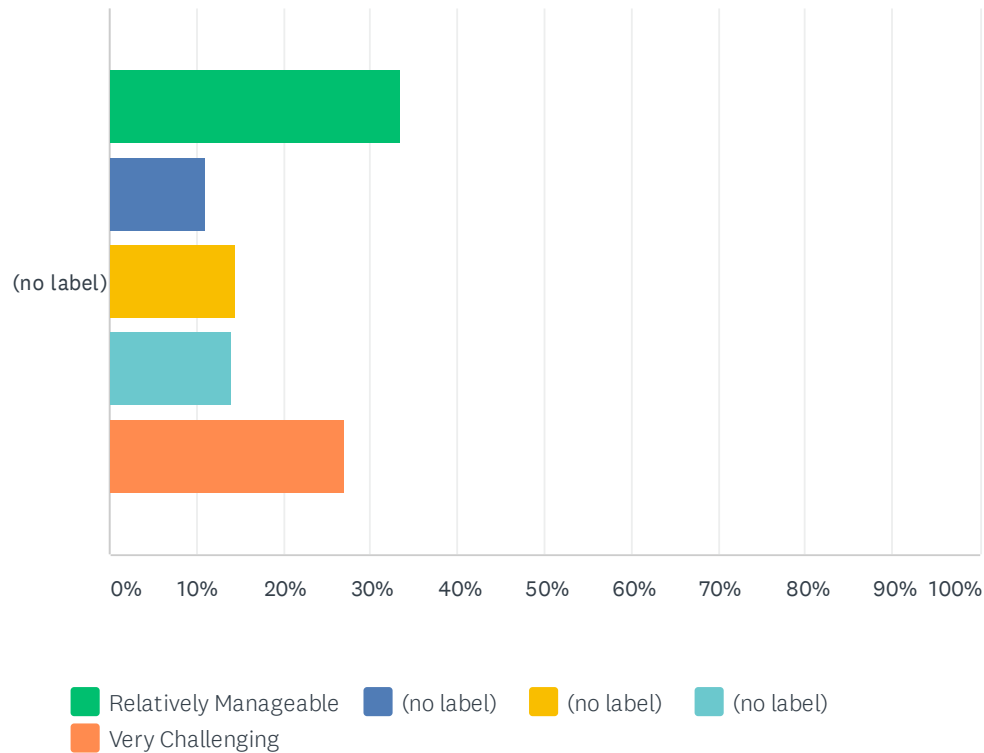

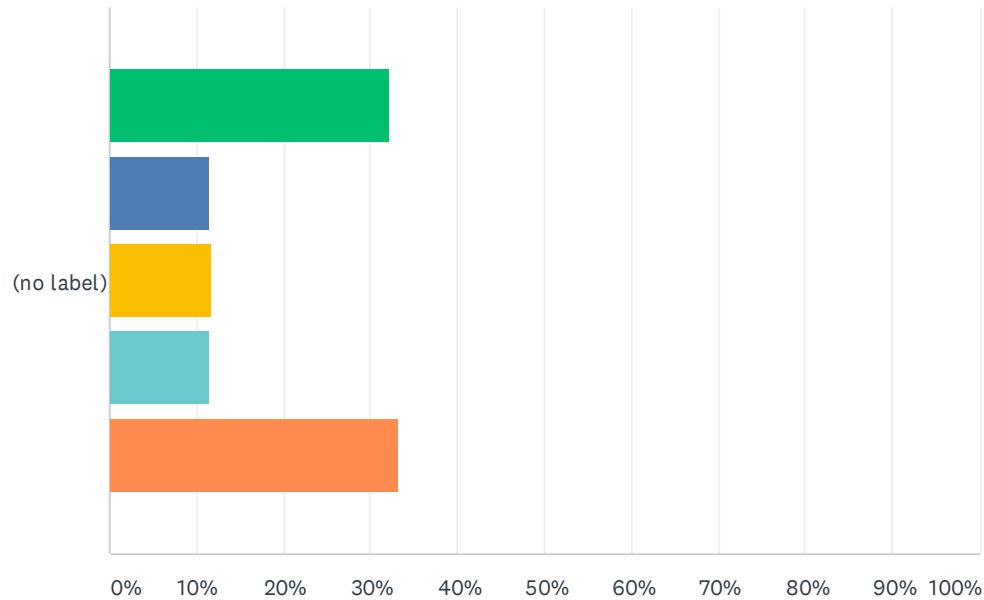

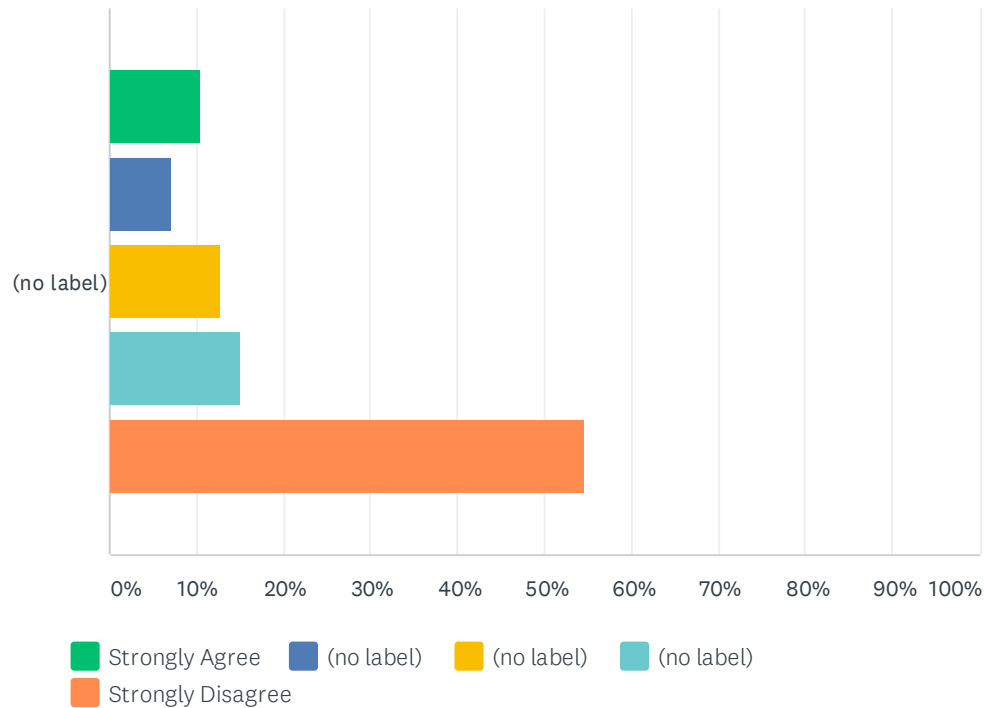

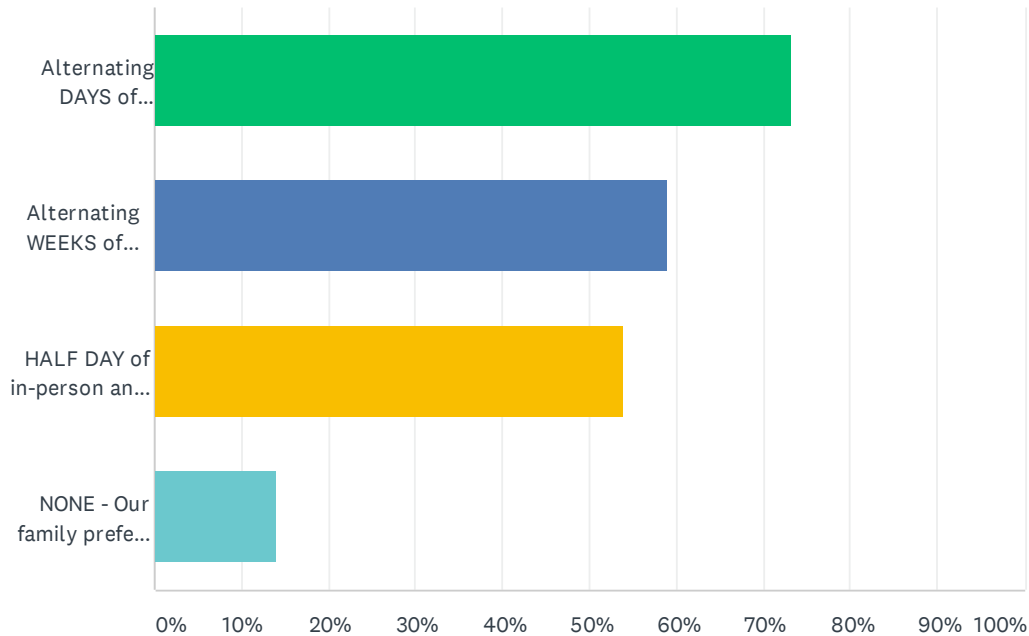

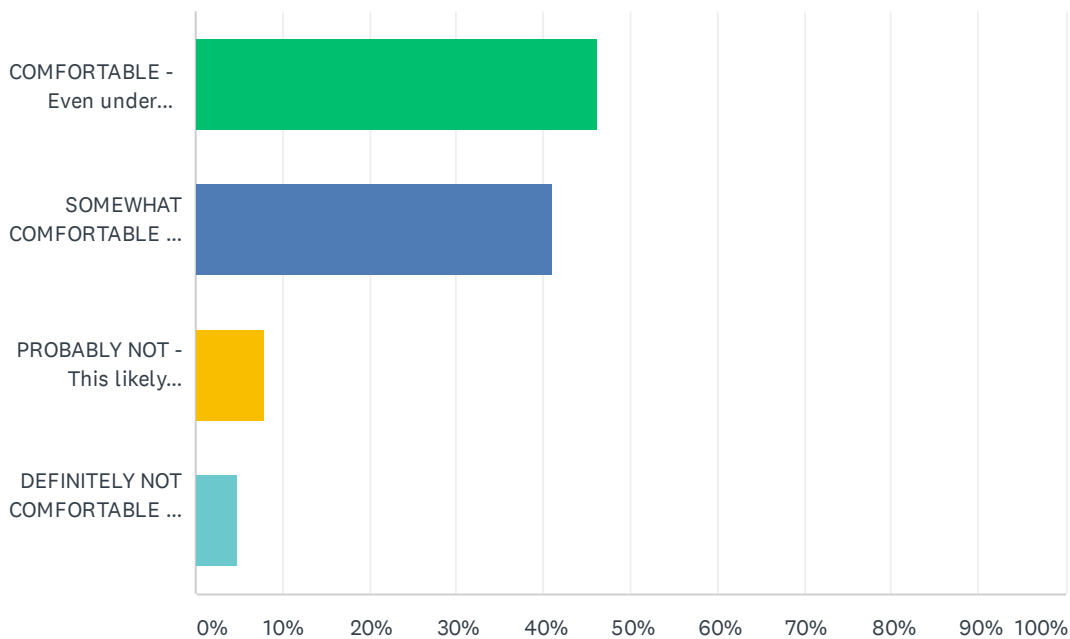

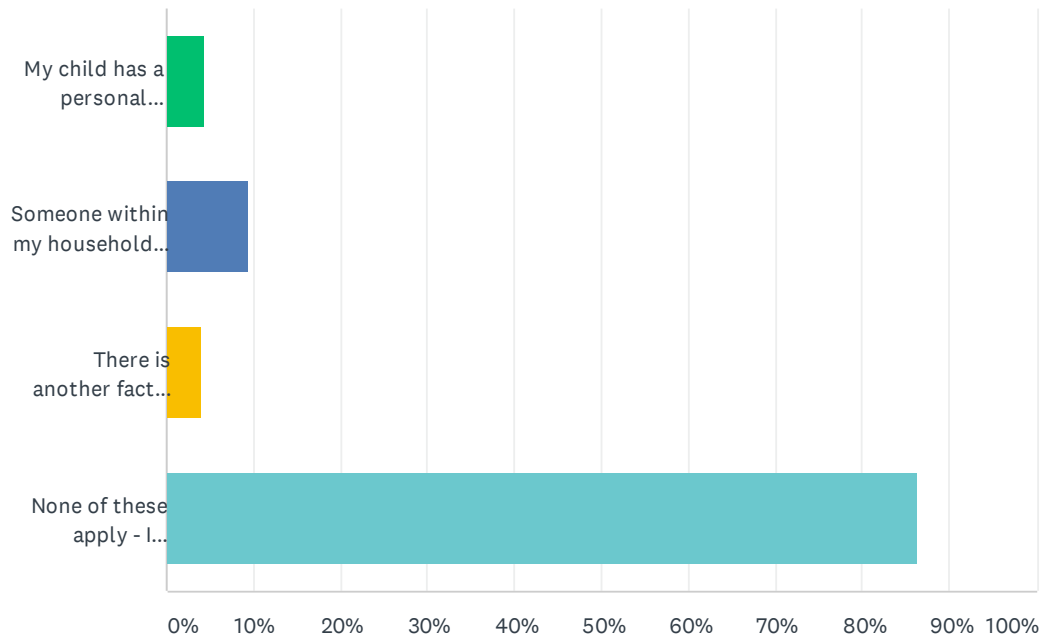

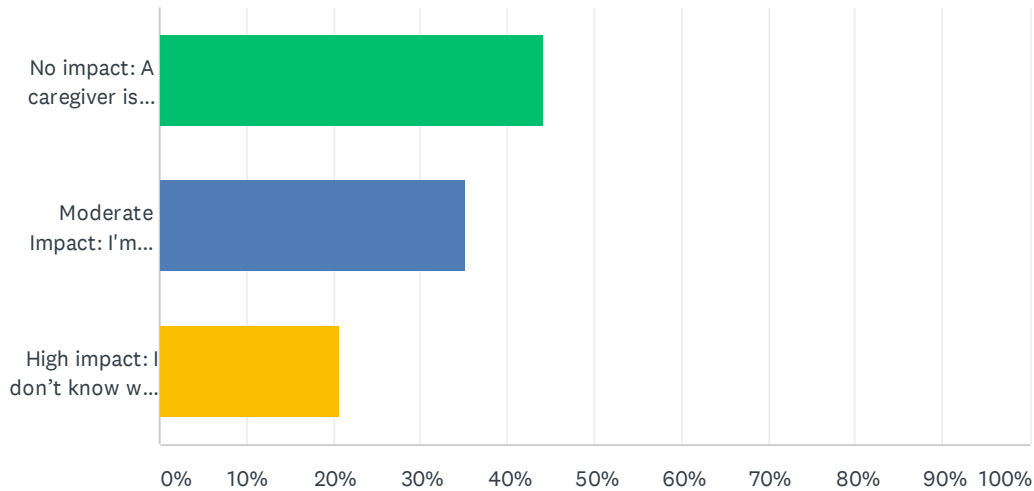

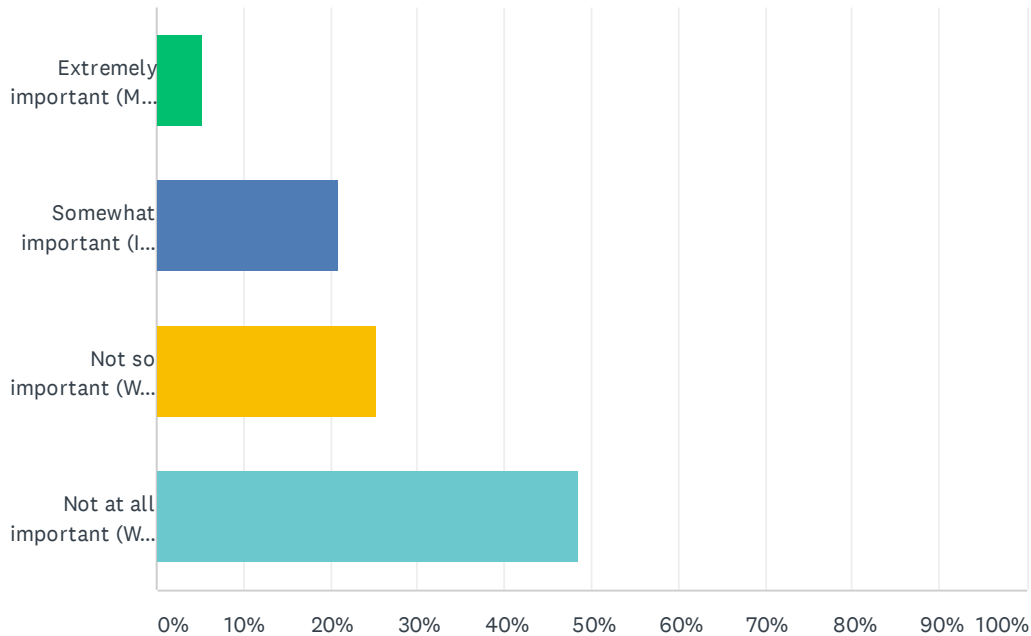

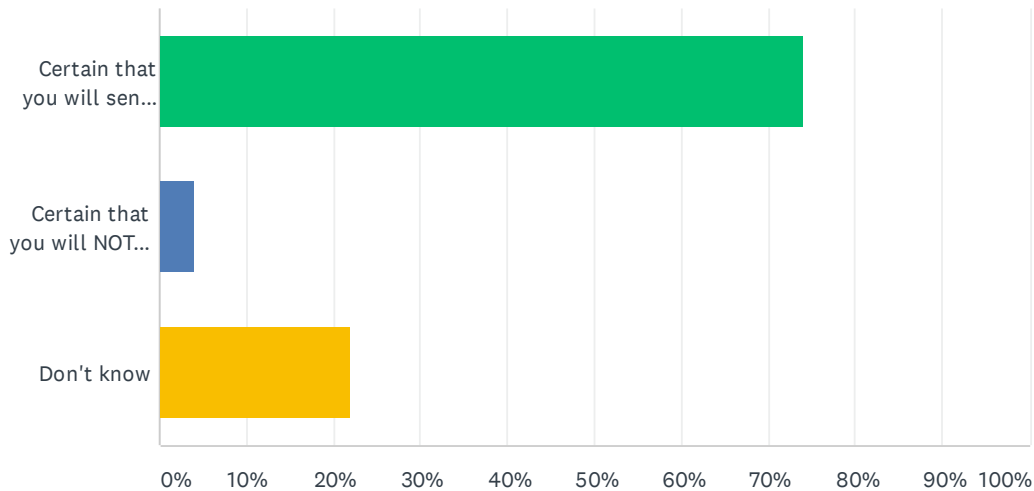

## **Parent Comments/Concerns Summary**

The open comment question responses are sorted by common words and reviewed by common words for main themes. 598 respondents provided a comment. Themes include:

What will happen if there is a case of COVID-19 in a school?

Will children from the same family be scheduled for the same day?

Will there be shared materials?

What will the day look like? Will specials teachers visit the classrooms?

Will there be symptom/temperature checks?

How will lunch, recess and bathroom breaks be handled?

How much access is there for Hand-washing and sanitizing?

Will face masks be required at all times or will children be able to take them off in the classroom? Many expressed concern about young children having to wear face masks.

What kind of support will be available on the at-home days or times?

If an alternate schedule is developed, strong concern that families of children be scheduled on the same day.

What are the plans to make remote learning more robust?

Will there be a different hybrid for special ed students?

Some support for sending youngest children first.

How will teachers evaluate COVID slide? How will that be addressed?
