Although we provide overhead lights, we strongly suggest you bring **battery operated lighting** for inside your booth.

Food & Merchandise Vendors policies and procedures

Vendor spaces are 10' x 10'.

You may not break down and leave prior to Sunday, October 8 at 4pm.

Requests are taken, but they are not guaranteed. Requests are based on first come, first pay and availability.

Cancellations must be in writing and submitted 30 days (or more) prior to event date.

Sellers are responsible for reporting and paying their own Sales Tax.

Booths must be appropriate and look professional.

If you are asked to remove objectionable merchandise, you must do so immediately or you will be asked to leave without refund.

All fire, health, safety and applicable laws and regulations must be adhered to by.

Electricity and water are not available.

Generators will be allowed in designated areas and must receive prior approval from the Chamber.

CAMPFIRES ARE NOT PERMITTED AND SMOKING IS NOT ALLOWED ON DRY GRASS!

Goods and services sold are at the discretion of the Chamber.

Failure to comply with policies, procedures, rules, regulations, laws, penal codes or instructions will be considered adequate grounds for immediate booth removal and there will be no refund. The Chamber reserves the right to refuse service to vendors and alter the specifics of booth space, location and size if necessary.
