Hoops2Heaven Premier League – This league is the premier middle school age summer league in the area and designed for players who love hoops! Players are grouped primarily by skill level, and we honor carpool requests if possible. The effective date for age participation is June 1, 2020. Ages 11-14 are eligible. Our league is coed. Play occurs twice per week for seven weeks on Monday, Tuesday, or Thursday evenings. The fee is \$100 per child (max \$250 family). First 66 are assured a spot.

Basketball Dreams Camp - The very popular Basketball Dreams camps sponsored by Hoops2Heaven are as follow: June 8-11 M-Th (9:30 am to 12:30 pm) and July 22-24 Wed-Fri (9:30 am to 1:30 pm) – coed ages 6-12. Fee is \$100 per child.
