EMERGENCY ORDER No. 2 of 2020

WHEREAS, on March 16, 2020, Columbia County declared a Local State of Emergency in the County due to the threat to public safety produced by the effects of the ongoing COVID-19 Virus; and

WHEREAS, the Local State of Emergency was extended for an additional THIRTY (30) day period commencing on April 15, 2020; and

WHEREAS, pursuant to the powers vested in me as Chairman of the Columbia County Board of Supervisors pursuant to New York Executive Law §24, which authorizes me to promulgate Local Emergency Orders upon a finding that the public safety is imperiled by the event of a public emergency or in the event of a reasonable apprehension of immediate danger thereof, to protect life and property and to bring an emergency situation under control; and

WHEREAS, to remain consistent with and in full compliance of all of the Governor's State of New York Executive Orders relative to the COVID-19 Virus,

it is hereby ORDERED:

Section 1. Closings.

All public and private summer camps and/or schools which provide overnight accommodations to minor children and counselors and/or teachers and/or staff of any age whatsoever, shall remain closed, or if operating, shall close, effective immediately until further notice.

Section 2. Effective Date

This Local Order shall take effect of Monday, April 27, 2020 at 12:00 a.m.

Section 3. Duration of Local Emergency Order

The Local Emergency Order declared in Section 1 shall remain in effect for FIVE (5) days unless extended or sooner rescinded. This Order may be extended for additional periods, each period not to exceed FIVE (5) days during the period of the Local State of Emergency.

Additional Local Emergency Orders will be promulgated by the Chairman of the Columbia County Board of Supervisors during this State of Emergency in order to further protect the life and property and to bring the emergency condition(s) under control.
