ABOUT THE EVENT

WHEN: **Saturday, December 7**

One of the featured events for the 2019 Parlor City Christmas. Registration starts at 12:30 pm. Human Truck Pull Tournament starts at 1:30 pm.

WHAT: Put together a team of either 10 men or a co-ed team of 12 and compete against other teams in a holiday-themed human truck pull tournament. Co-ed teams must have at least 4 female members. Teams will pull a 33,000 pound semi-truck with 53 foot trailer as fast as they can to cross the finish line 100 feet away. Each “pull” will be timed but you will be racing beside another team. The two fastest teams will then do a final pull-off to determine the winning team of the tournament and the bragging rights for Fastest Team Overall, along with a small prize. We will also be awarding a Spirit Award for most creatively dressed team.

WHO: Participants must be 18 years of age or older.

WHERE: **200 block of Market Street (Downtown Bluffton, IN)**

Please check-in at the registration table in the alley near the Resource Maintenance building along Market Street.

COST: **\$50 per team**

HOW TO PARTICIPATE:

- Recruit your team members and assign one person to be your team captain and contact person.
- Team captains will need to pre-register for the tournament by filling out the TEAM PRE-REGISTRATION form and having all team members sign the RELEASE OF LEGAL CLAIMS.
- Submit all forms and \$50 fee by Saturday, November 30.
- On the day of the event, all team members will need to check in at the register table to receive wristbands to participate.

WEAR THE DAY OF THE EVENT: team members will need to bring your own gloves, which are recommended to protect your hands from the truck pull rope. No cleats will be allowed to be worn. Since we are awarding a “Spirit Award” we strongly encourage teams to get in the holiday spirit and wear a costume of some kind. It can be related to your team or the holidays as a whole (such as all of the reindeer). If you don’t wish to participate in the spirit award, any outfit is fine (just dress warm).

RELEASE OF LEGAL CLAIMS

MY HEALTH CONDITION:

I don't know of any health condition that I have that could get worse if I participate in the truck pull. I authorize staff and volunteers at the truck pull to get emergency medical treatment for me during the truck pull.

RISKS OF PARTICIPATING:

I know that pulling a semi truck and trailer is dangerous and that I could get hurt or seriously injured participating in the truck pull. But I accept all the risks involved in participating.

USE OF LIKENESS:

I grant Parlor City Christmas and it's committee member permission to use my name, pictures of me, and things I say in any form to advertise themselves or to apply for funds related to their activities.
