START WITH SAVING- AN ERIE COUNTY FOOD WASTE REDUCTION INITIATIVE GRANT APPLICATION

Erie County submitted a grant application to NYSDEC for a pilot project focused on developing and implementing prevention solutions to reduce food preparation waste and what is left on the plate. Understanding the type, amount and timing of food would provide Erie County and its partners information to formulate targeted education and outreach activities to address this waste stream. If funded a state of the art, industry recognized food waste tracking and analytic system will be used for data collection. The data will be used to create specific interventions and educational materials and outreach focused on institutional food preparation activities that will be useful in Erie County and statewide.

TAKE-AWAYS FROM THE THEY'RE DEMANDING LESS WASTE WORKSHOP

On March 4, 2019, DEP and partners Alliance for the Great Lakes, Buffalo Niagara Waterkeeper and Citizens Campaign for the Environment held a workshop on reducing food waste and single use plastics at restaurants and special events. Panelists, Deb Friedel: Delaware North, Prish Moran: Sweet_ness 7 Cafe, Nicole Wurtsner: Service Systems Associates and Jennifer Brazill, Borderland Festival, spoke about their businesses experiences in reducing single use plastics and food waste to an audience of 50 people from around the County.

The audience appreciated the perspectives of small and large organizations expressed by the panelists. Feedback about the event was positive, with attendees requesting additional regularly scheduled events geared toward businesses to continue exploring solutions for these issues
