## RELEASE OF LIABILITY FOR TEMPORARY VOLUNTEERS\*

*Before you can participate in Gilroy's volunteer programs, we require you to sign the City of Gilroy's Release of Liability. If you are under 18, you must have this form signed by your parent/guardian.*

Personal Property Damage: The environment in which we will work may damage your personal property, especially your clothing. If your property is damaged, you agree to hold the City harmless. This means you will not file any claims against the City for any personal property damage related to your volunteer work even if the damage is caused by the negligence of a City employee. We strongly urge you to use common sense and care.

Injury to Third Persons and Their Property: In addition to your own safety and that of other volunteers, we want you to take every step possible to protect the safety of other residents and visitors to our City. You must take every reasonable precaution to prevent injury to others and to prevent damage to their property.

Photo/Image Release: In further consideration of the services being provided by the City of Gilroy to the participant(s) identified herein, the undersigned agrees, on behalf of himself/herself and on behalf of the participant(s) identified herein, that the City of Gilroy may use photographs, videos, motion pictures and/or other recordings that contain visual images of the participant(s) identified herein in City of Gilroy promotional materials related to the City of Gilroy and/or its free or paid events, classes, activities and/or programs.

Special Covid-19 Release and Indemnification: I am aware that during the current COVID-19 epidemic, even if social distancing measures are observed there is a risk that myself and/or event attendees may contract the virus while present at my reservation.
