What is possible to change or grow in working with congregations when the resistance and anxiety are forces to reckon with and old methods are frustrating and useless? Transitions are accomplished in liminal times when, what needs to be is left behind and new visions are before us. This principle and its adaptive challenge corollaries applies both to congregations and to us as transition leaders. It's both a spiritual, biblical, pattern for God's People and a model for ministry.

This important tool should be the first "go to" in every Practitioner's toolbox. This often overlooked resource is free to every congregation. In fact, it ought to be the first step in helping a congregation to see opportunities where others see crisis! Used correctly, this tool can assist struggling congregations by discovering what their communities have already identified as the most critical areas where they are searching for connection or quidance.

## Session 11 - The Right People at the Right Time: Tools for Congregational Renewal - Putnam/Bokre 7:00 pm - January 20

Many congregations in transition want new ideas to spark renewal. But renewal doesn't begin with ideas — it begins with people. This workshop will briefly review the life cycle of congregations and then introduce two leadership frameworks — Paterson's Thinking Wavelength and Lencioni's Working Genius. Together, these tools help pastors and congregations identify the kinds of people needed at different stages of rebirth. Through teaching and interactive exercises, interim pastors will practice using these frameworks to better assess, empower, and align leaders in their congregations for long-term renewal.

This Boundary Violation illuminates one of the many Practitioner pitfalls we face, namely, to over function in under functioning congregations. The "Arm's Length Boundary," especially as it applies to the Task Force and Call Team, protects the system from directly or indirectly being influenced by the Practitioner as he leads and guides them through the TIM process. By trusting and allowing the Holy Spirit to work within the system, we strive to avoid the inclination to be the "Savior/Rescuer" especially in congregations that crave it. This principle is critical to our own self-differentiation and the maintaining of healthy boundaries.
