Federal Update

Week in Review

1

HEROES Act (May 15):

Senate back in session this week and the House is out. Senate Majority Leader Mitch McConnell (R-KY) said action on the next potential coronavirus relief bill won't come for at least a month. |

HHS Provider Relief Fund:

HHS has not disbursed any additional funds this week, however they are poised to disburse the remaining ~\$100B by July 15. The next tranche will focus on SNFs that did not receive funding to date. Later, dentists; pediatricians; and other Medicaid providers. Lastly, there *may* be a reconciliation disbursement to account for under-funded providers.

PPP Flexibility Act (H.R. 7010): Thursday (May 28), the House overwhelmingly passed a bill easing terms of the Small Business Administration's Paycheck Protection Program.

HRSA Uninsured Portal:

Health care providers who conducted COVID-19 testing or provided treatment for uninsured individuals with a COVID-19 diagnosis on or after February 4, 2020 can request claims reimbursement (MCR rates) through the program, subject to available funding.
