Financial Presentation and Discussion:

• 2019 Financials – Treasurer John Galich reported:

- The 2019 income was \$422,334. The 2019 expenses were \$408,334. This leaves a surplus of \$14,000 versus a planned balanced budget.

After a motion and second the 2019 budget was approved as submitted.

• 2020 Financial Statement of Mission – Paul Smejkal, Finance Committee Chair reported:

- The 2020 planned income is \$407,000. The 2020 planned expenses are \$433,501. This leaves a deficit budget of \$26,501 for 2020.

After a motion and second the 2020 budget was approved as submitted.

Sara Kuyper reminded the congregation we need to fund a youth minister.

• Cornerstone Endowment – David Niles, Chair reported:

- Four regular gifts and 3 memorial gifts were received in 2019
- Forty regular gifts and 23 memorial gifts have been received since inception
- Sixteen families/individuals have made a pledge of future contribution via cash, stock, life insurance or bequest in their will through estate planning
- Total balance as of 12-31-17 was \$117,243
- Total balance as of 12-31-18 was \$293,382
- Total balance as of 12-31-19 is \$353,540
