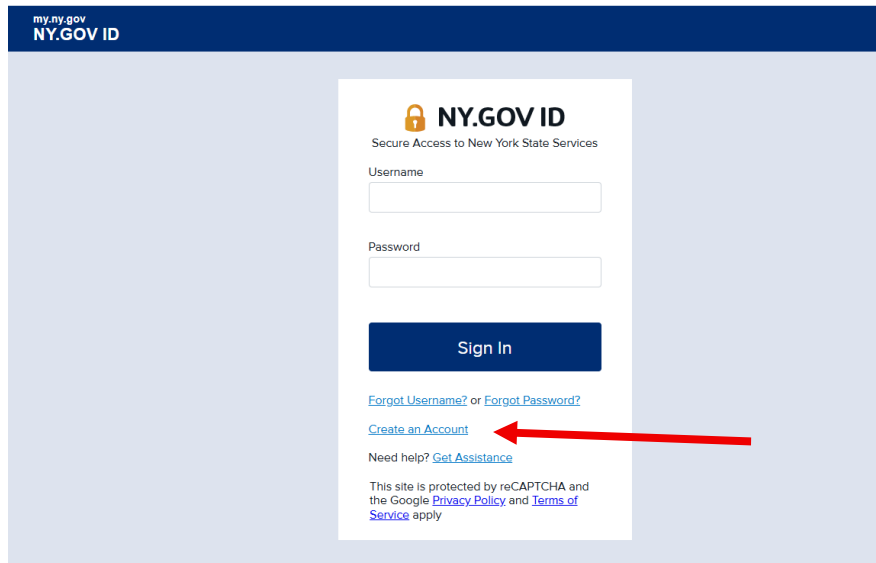
2. Scroll down and click the Glove City Lofts Lottery Box.



3. Click the Yellow Bow that says: register/login to Apply.

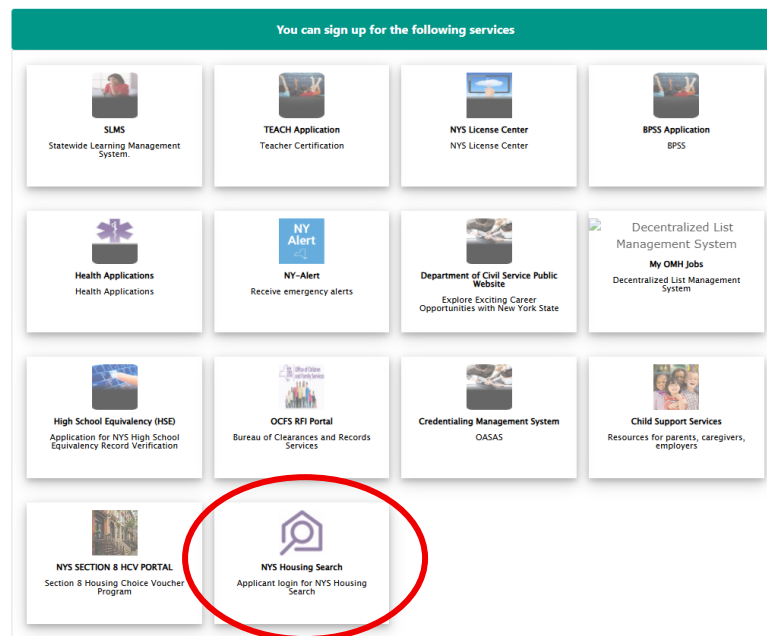


4. You will need to create a NY.Gov ID to fill the application out online.



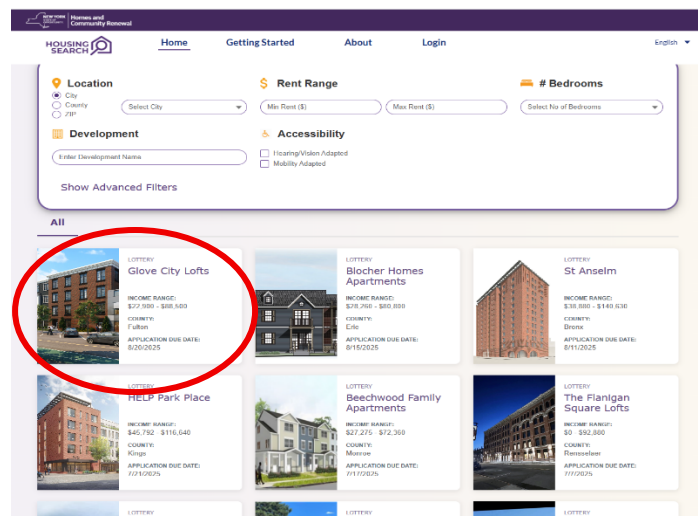
