Admission is FREE to the public.

Milan Dawg Daze will be held Saturday, August 26th. It will be located at the Milan City Park, 7001 Ellington Drive, Milan, TN 38358. Check in and set up will begin at 7:00 a.m., as well as the Pancake Breakfast and 5K registration. Please have your booth set up before 10:00 a.m. and do not pack up to leave before 4:00 p.m.

Booth space measures approximately 15 feet wide and 10 feet deep. Tents are optional, but recommended. They must be free standing and cannot be staked into pavement. Please weight them to withstand wind. No tables, chairs or tents will be provided by the festival.

The early-bird entry fee for one booth is **\$60. Early-bird deadline is July 26, 2017.** Booth fee after July 26th is **\$75.** Additional booths are \$50 each. Non-profit entry fee is \$40 per booth. Generators are preferred. **Electricity (110 - 20 amp service only) is available on a limited basis at an additional cost of \$25.** *Please do not pull more than this as it will shut down the electricity for everyone!!*

**ALL VENDORS MUST PROVIDE A CERTIFICATE OF INSURANCE NAMING THE CITY OF MILAN, TN AND MILAN CHAMBER OF COMMERCE AS ADDITIONAL INSURED.**

**FEES ARE NON-REFUNDABLE AFTER JULY 26, 2017.**
