- 2. Applications **MUST BE RECEIVED** at the Association office **BY 4:45 p.m.** <u>Tuesday, January 11, 2022</u>. <u>NO EXCEPTIONS.</u>
- 3. All decisions of the Selection Committee are final.
- 4. If you have reassociated/transferred to a new office during 2021, please be aware that your current manager/Broker or Designated Realtor® may sign this form for you.





ELIGIBILITY

- 1. REALTOR® must have membership for one full calendar year.
- 2. Members applying for the Rising Star Award must be in good standing. A member in good standing means:
 - Having completed New Member Orientation and completed the NAR Code of Ethics training.
 - Paid all financial obligations to RAPV.
- 3. All membership meetings and networking events have sign-in sheets. Members must have signed-in for all meetings and events to be given credit. The Review Committee reviews the sign-in sheet as the qualifying record of your attendance. If you are using someone else's reservation, you had to specify such on the sign-in sheet. If you purchase a ticket and are unable to attend a meeting or event you **cannot** take credit.
- 4. REALTOR® must have been licensed in the past 18 months
- 5. Must have attended and completed RAPV Orientation and the NAR required Code of Ethics
- 6. May self-nominate or be nominated by their home office, based on office and community involvement
- 7. Must have worked as a first time REALTOR® for said office
- 8. Must meet the SERVICE QUALIFICATION. You do not have to serve on a committee to qualify.

Note: If there are multiple applicants for the Rising Star Award, the recipient will be the applicant who is the top producer amongst the applicants.
