### Property Sales / Volume

### Individual

Platinum: Over \$10M in sales or 48+ units

Gold: Between \$6,000,001 and \$10M in sales or 37 - 47 units

Silver: Between \$3,000,001M and \$6M in sales or 24 - 36 units

Bronze: Between \$1M and \$3M in sales or 16 - 23 units

### Team

Platinum: Over \$18M in sales or 85+ units

Gold: Between \$12,000,001 and \$18M in sales or 73 - 84 units

Silver: Between \$6,000,001M and \$12M in sales/transaction or 47 - 72 units

Bronze: Between \$2M and \$6M in sales/transaction or 32 - 46 units
