## Workers Catch a Break from (Un)fair Share Fees in the Janus v. AFSCME Decision

If government unions want to use their money for political activity, then ok, but non-members shouldn't have to pay for it.

That's what Mark Janus argued in his case against the government union that represents him and other Illinois municipal workers. The Supreme Court ruled for him this June in Janus v. AFSCME, concluding that so-called "fair share fees" violate workers' First Amendment rights by forcing them to pay for political speech they disagree with.

## ACA Compliance Bulletin

### Draft Forms for 2018 ACA Reporting Released

The Internal Revenue Service (IRS) released draft 2018 forms for reporting under Internal Revenue Code (Code) Sections 6055 and 6056.

2018 draft Forms 1094-C and 1095-C were released July 11, 2018, and will be used by applicable large employers (ALEs) to report under Section 6056, as well as for combined Section 6055 and 6056 reporting by ALEs who sponsor self-insured plans. [Read More>>](#)

## Compliance Bulletin

### HSA/HDHP Limits set to Increase for 2019

On May 10, 2018, the IRS released Revenue Procedure 2018-30 to announce the inflation-adjusted limits for health savings accounts (HSAs) and high deductible health plans (HDHPs) for 2019. These limits include:

- The maximum HSA contribution limit;
- The minimum deductible amount for HDHPs; and
- The maximum out-of-pocket expense limit for HDHPs.

These limits vary based on whether an individual has self-only or family coverage under an HDHP. [Read More>>](#)
