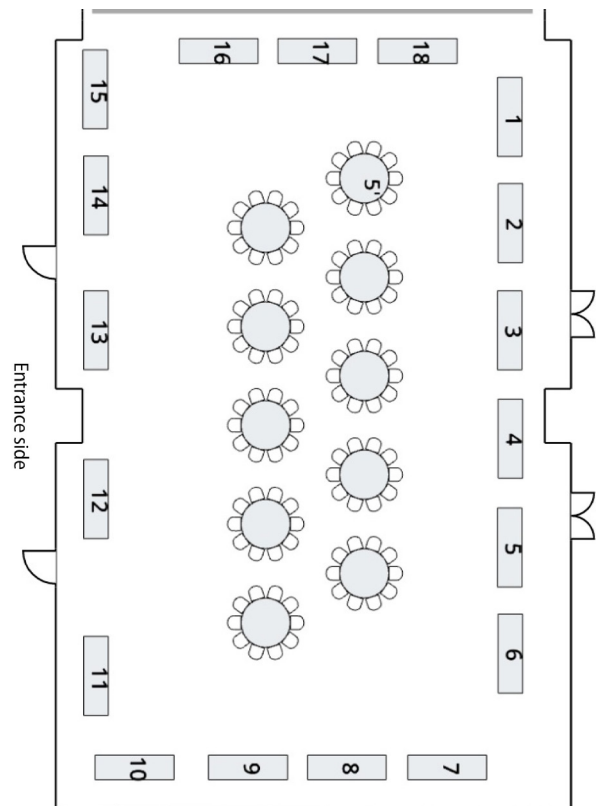
FLOORPLAN and ASSIGNMENT of SPACE
