Leg Committees Begin Action

Hundreds of bills introduced

Lawmakers will spend most of this week in committee meetings as chairmen use the last full week available to tackle general bills and constitutional amendments referred to their committees. General bills not approved in committee by Feb. 5 will die via a procedural deadline, a fate awaiting the majority of proposals filed.

Committees dealing with issues ranging from education, to healthcare to public safety to civil lawsuits are expected to tackle bills; however most chairmen have signaled their intentions to limit the range of bills that will reach the House and Senate floors.

Broadband sent to Governor: The Senate last week sped through approval of [HB 366](#) that opens the door for rural electric power associations to borrow against their electricity business and compete in delivering broadband to rural areas. Overwhelming and hurried approval in both chambers comes after a two-year campaign by Democratic Public Service Commissioner Brandon Presley who championed the concept as a game-changer for rural economic development. It's unclear, though, what the bill will do to answer the fundamental financial barrier: delivering expensive services and equipment to sparsely populated areas with fewer customers to pay for it all. The bill now moves to the governor's desk for his signature.

Human Trafficking: The House also overwhelmingly approved [HB 571](#) – Speaker Philip Gunn's (R-Clinton) push to combat human trafficking. The measure, which now goes to the Senate, was approved by the House. It will require more training and reporting requirements to help law enforcement and health professionals and others identify and care for victims of trafficking. The measure also relieves minors of criminal penalties when forced into prostitution.

Prayer List: Sen. Terry Burton (R-Newton), who earlier this session resigned his position as president pro tempore of the Senate, suffered a stroke Friday and was hospitalized. Burton is a veteran of the chamber who has worked on a broad range of issues and budgets.

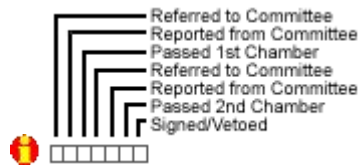
