Below are the highlights and table reflecting last week’s activity:

- Ten year UST yields fell two basis points to 1.56%
- Ten year AAA muni yields were unchanged at .93%
- The ten year muni to treasury ratio moved from 59% to 60%
- The thirty year muni to treasury ratio moved from 68% to 69%


