

Weekly Review July 22nd- July 26th, 2019**Market Commentary Week ending 7/26/2019**

Below are the highlights and table reflecting last week's activity:

- Ten-year Treasury yields rose 3 basis points to close at 2.07% on Friday.
- Ten-year AAA muni yields declined by 2 basis points to finish the week at 1.54%.
- The ten-year muni to Treasury ratio widened by 2 percentage points from 76% to 74% by Friday.
- The thirty-year ratio widened by one percentage point from 88% to 87%.
