### Market Commentary Week ending 11/8/2019

Below are the highlights and table reflecting last week's activity:

- Ten-year Treasury yields rose 22 basis points to finish the week at 1.94%.
- Ten-year AAA muni yields increased by 11 basis points to close at 1.60% on Friday.
- The ten-year muni to Treasury ratio widened by 5 percentage points from 87% to 82%.
- The thirty-year ratio widened by 2 percentage points from 94% to 92%.The thirty-year ratio narrowed by 2 percentage points

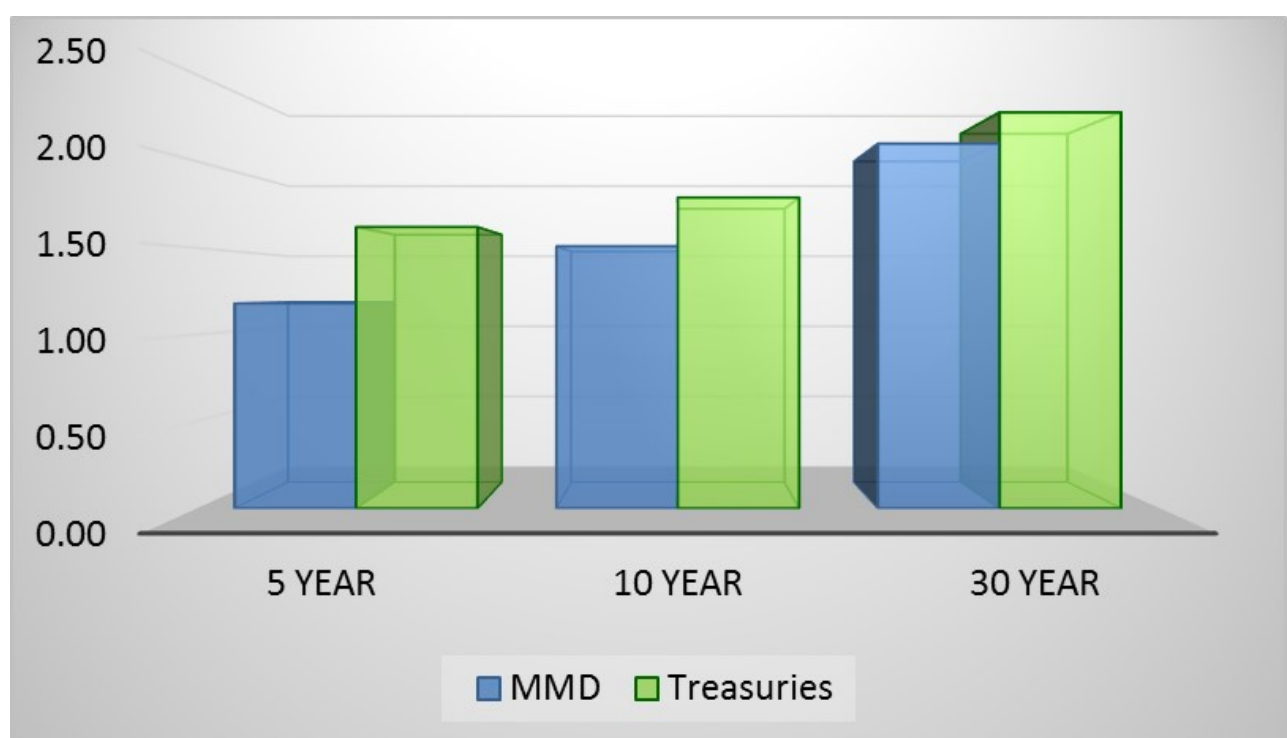
